

# Washington State has two occupant protection laws:

#### The Seat Belt Law:

- All vehicle occupants must be properly restrained in all seating positions;
- The driver is responsible for properly securing all children under the age of 16.
- Passengers 16 years of age and older are responsible for themselves. They may receive their own citation if they are not properly restrained.
- Buckling one seat belt around two people or placing the seat belt under the arm or behind the back is dangerous, can cause death or serious injury, and is a violation of the law.

#### The Child Restraint Law:

- Children under 13 years old must travel in the back seat when practical.
- All car seats and booster seats must be used correctly according to the car seat AND vehicle manufacturer's instructions.
- Children who are under 8 years of age or under 4' 9" are required to remain in a child restraint. When your child reaches 4' 9" they may try the adult safety belt. If it does not fit correctly they must remain in a child restraint.

### Safety seats - What you need to know

#### • Rear-Facing Seats:

Keep children in the back seat, in rear-facing child safety seats as long as possible – up to the height or weight limit of the particular seat. Children are five times safer riding rear-facing than forward-facing into their second year of life.

#### • Forward-Facing Seats:

When children outgrow their rear-facing seat they should ride in a forward-facing seat, in the back seat, until they reach the upper weight or height limit of the particular seat.

#### Booster Seats:

Once children outgrow their forward-facing seats they should ride in booster seats, in the back seat, until the vehicle's seat belts fit properly. Seat belts fit properly when the lap belt lays across the upper thighs and the shoulder belt fits across the shoulder and chest.
