Joining terrorists for a tea party

I hadn't planned to attend the local "tea party" protests. These days, both Democrats and Republicans go stone deaf when confronted with demands of fiscal responsibility. Napolitano: "That's difficult to say."

Well, Pullman's tea party deployed weapons of mass politeness. The signs were civil. Voices were temperate, except for one fellow who shouted, "Throw the bums out." But I'm pretty sure he was talking about the ballot box.
