2. I am employed by the City of Spokane as the Director of the Management Information Services (MIS) department. In that role, I manage the City's information systems, its computers, the mail and internal delivery system, and the telephone and communications systems. I have been the director of MIS since August 1998. I have a Bachelor of Science degree in Computer Science from the University of Southern Mississippi, and a Masters degree in Systems Management from the University of Southern California. I was in the United States Army from 1966 to 1993 and retired in 1993 at the rank of Lieutenant Colonel.

From November of 2008 through June of 2009 I have responded to 7 3. or 8 subpoenas issued by the U.S. Attorney's Office. All of them requested the production of any electronic records related to the arrest and subsequent death of Otto Zehm. At least two of them were delivered to me on the day of or day before I was requested to testify. Most of them were duplicative, addressed to the wrong person, and requested email messages that had been purged from our system in accordance with city policy. The majority of messages that we recovered that were responsive to the subpoenas came from the personal folders maintained by individuals named in the subpoenas. Because personal folders were replaced by newer technology in February of 2008, the production of responsive records required us to restore massive amounts of data from our offsite magnetic tape storage facility. We have also had to add storage capacity our email archiving and search system to enable these searches. My email DECLARATION OF GARV BRAKEL - 2

administrator, computer operators, and I have spent over 100 unreimbursed hours producing relevant records.

4. We have never sought to have a subpoena quashed. We have always attempted to locate and provide whatever has been requested. On occasion, we have had to ask the U.S. Attorney's Office to help us clarify a request in order to be able to locate the material or information they sought if the request was overbroad. The City and the U.S. Attorney's Office have been able to successfully work out such overly-broad requests.
