On $10/27/09\ \mathrm{I}$ spoke with Rachel Hammontree concerning the burglary of her vehicle.

Rachel told me she parked her vehicle under a carport in her driveway last night.

. At 1900 hours she viewed the vehicle and knew her property to be in place. Rachel said it is her habit to lock her vehicle, but she believes it may have been unlocked last night. When she returned to her vehicle at 0720 hours this morning she discovered several items missing from the vehicle. She found no sign of forced entry and no damage to the vehicle. Her IPOD, which had been plugged into the dash, was missing. The adapter and cord were not taken. The IPOD case was taken from the center console of the vehicle. A \$50 bill which Rachel kept in the center console was also missing. Rachel said three rolls of quarters kept in the center console were untouched. Rachel could provide no suspect information.
