NARRATIVE:

On 11/19/09 Donna Cork of the Human Rights Education Institute (HREI) called the PD to report harassment. While I was calling to take the initial information I received a message from the watch commander, Sgt Brainard, requesting I respond to the scene to take pictures.

I called HREI and requested to speak with Donna but was told she was busy with the media. I spoke instead to Rachel Dolezal, Director of Education for the Institute. Rachel told me someone had placed a Swastika sticker on the front (east) door of the Institute. Rachel said she was the last person to leave last night at 1745 hours and the sticker was not there at that time. Rachel requested I respond to the scene.

I went to the scene and observed a female taking close-up pictures of the door and decal. I did not identify the female and waited for her to finish so that I could continue my investigation. I later determined this female was with the media and she continued to take pictures throughout my investigation. I observed an approximately four inch by four inch decal on the exterior east-facing entry door of the building. This is a double glass door and the decal was affixed to the southern-most door. The decal depicted a black Swastika symbol in a white circle on a red background. I took a photograph of the decal.

I spoke with Donna Cork, Director of Operations for HREI, on scene. Donna told me she discovered the Swastika sticker on the door when she arrived at work at 0830 hours this morning. Donna did not see anyone suspicious in the area and could provide no suspect information. Donna said she had not had an opportunity to check for any further damage to the exterior of the building. I checked the perimeter of the building with Donna. We noted no further damage and nothing of evidentiary value. A discarded wet cigarette butt lay in the planter at the southeast end of the building. I did not collect the cigarette butt. I did not attempt to lift fingerprints from the decal nor did I dust the exterior of the door for prints. The weather was rainy and the surfaces were damp. Donna said the exterior of the building does have motion sensitive lighting and there is a video surveillance camera. Donna said she had not yet reviewed the surveillance video. I requested she contact the PD if the video revealed any suspect information.
