INCIDENT NARRATIVE: Moore was westbound on I90 at milepost 6 when she lost control of the Ford Expedition she was driving, crossed the center median, entered the eastbound lanes and was struck by three eastbound vehicles. The drivers of the eastbound vehicles were Thomas in the Chevy Impala, Kinnick in the Dodge Pickup and Eschliman in the Dodge Durango. It is still being determined at this in what order the vehicles struck the Expedition as it entered the eastbound lanes. Alcohol was not a factor in the crash. Destiney Moore was pronounced deceased at the scene and Michael Martinez died at Kootenai Medical Center. Investigation is continuing.
