## INTRODUCTION

The following report was compiled on July 14, 2010 at the request of Captain Childers. The types of information used to create this report include calls for service, crime reports and field interviews extracted from our Summit database.

Database records were reviewed and compiled based upon both how the record is related to a specific bar or bar activity in general in the downtown Coeur d'Alene area. The following is a table of the establishments and addresses associated with them.

Notably, it is not always possible to obtain information about where a suspect may have been drinking (e.g. too inebriated) or if a particular crime is directly related to a specific establishment. In that context, the **purpose of this report is to provide a general overview of downtown activities in an effort to increase communication between bar establishments and local law enforcement with the final goal of improving public safety.**

**Information on BAC (Blood Alcohol Content) as referenced in this report:**

**State of Idaho BAC DUI Laws:**

- **All drivers** with a **BAC .08** or higher (enhanced if **BAC .20** or more)
- **Under 21 years of age** with a **BAC of .02** or higher
- **Commercial Drivers** with a **BAC of .04** or more

**Wednesday, July 7, 2010: 2222 hours**

**407 E Sherman Ave – Alcohol Offense - #CD1366426**

Officers observed a male and a female with beer outside the chained area of the **Iron Horse**. The officer spoke with the bouncer standing at the front door who advised the couple were arguing with him to let them inside.

**Wednesday, July 7, 2010: 2225 hours**

**424 E Sherman Ave – Alcoholic Offense - #CD1366462**

Officers observed approximately eight people outside of **Cricket's** with alcohol. They spoke with the servers who advised they would move them inside.

**Friday, July 9, 2010: 0205 hours**

**N 4<sup>th</sup> St & E Garden Ave – DUI - #10C19234**

Officers pulled over a vehicle after it blew through a stop sign (forcing the patrol vehicle to suddenly brake) and arrested a 21 year old male for DUI (**BAC = .156**). The suspect advised he had consumed three Red Bulls and Vodka earlier at the **Beacon**.

**Friday, July 9, 2010: 2343 hours**

**115 N 2<sup>nd</sup> St – Disorderly - #CD1367086**

Officers responded to a Disturbance call at the **Baja**. The fight was broken up prior to arrival with several intoxicated people out front.

**Friday, July 9, 2010: 2345 hours**

**E Sherman Ave & N 6<sup>th</sup> St – Domestic Battery - #10C19358**

Officers responded to the 500 block of Sherman regarding a physical domestic dispute between a 46 year old male and 38 year old female. The female was locked in the vehicle and the male was pounding on the vehicle. Apparently they had been drinking at the **Iron Horse** and the male wanted to return home (Budget Saver Motel); however, his wife wasn't ready to go, so he grabbed and drug her to the car. The suspect's story was different maintaining he didn't want her to drive drunk so he tried to get her keys, but she locked herself into the car and when he jumped over the hood to get in the passenger side, she accidentally slammed his hand in the door (didn't need medical but that's when his wedding ring broke). The victim's story was she didn't want to leave the bar. She told the officer it had been a good day—they had married earlier that day and spent the day at the beach. The suspect was arrested for domestic battery.

**Saturday, July 10, 2010: 0102 hours**

**N 4<sup>th</sup> St & E Sherman Ave – 10C19363 - #10C19363**

Officers observed and cited a 27 year old male drinking beer outside of the **Moose Lounge**. The suspect was from out of state and did not know of the open container ordinance.

**Saturday, July 10, 2010: 0107 hours**

**317 E Sherman Ave– Alcoholic Offense - #10C19364**

Officers observed and warned a male with an open container who had walked past security to the outside of the **Icon**.

**Saturday, July 10, 2010: 0114 hours**

**100 Block of N 5<sup>th</sup> St – Disorderly - #10C19365**

Officers cited a 23 year old male for urinating in public.

**Saturday, July 10, 2010: 0116 hours**

**401 E Sherman Ave – Alcohol Offense - #CD1367109**

Officers observed a group of people drinking at a table outside of the **Moose Lounge**. The people and bartender were warned.

**Saturday, July 10, 2010: 0119 hours**

**115 N 2<sup>nd</sup> St – Alcohol Offense - #CD1367110**

Officers observed a male stumbling across the street from the alleyway north of Sherman Ave. The male was heavily intoxicated and told officers he had been drinking at the **Baja** all evening.

**Saturday, July 10, 2010: 0124 hours**

**100 Block S 2<sup>nd</sup> St – Alcohol Offense - #CD1367112**

No further information available.

**Saturday, July 10, 2010: 0140 hours**

**313 E Sherman Ave – Disorderly - #10C19370**

Officers noticed a 23 year old male for urinating on the wall of the **Wine Cellar** building (near parking lot). He was cited for urinating in public.

**Saturday, July 10, 2010: 0148 hours**

**216 E Coeur d'Alene Ave – Assault - #10C19372**

Officers arrested a 22 year old male at the **Torch** after a scuffle with bouncers. Apparently the suspect had been drinking at the Torch all evening until there was a dispute about smoking (possibly marijuana) in the bar. The suspect's escort out of the bar involved yelling, pushing, pulling, kicking and neck holds. Once the suspect was out the door, he was confronted by an officer who, noticing the suspect had a small knife, told the suspect not to touch the knife. The suspect reached down and grabbed the knife, the officer drew his gun, the suspect dropped the knife, and after back up patrol units arrived, the suspect was cited for assault.

**Saturday, July 10, 2010: 0200 hours**

**317 E Coeur d'Alene Ave – Alcohol Offense - #10C19375**

Officers cited a 22 year old male outside the **Icon** for open container after observing the suspect holding a beer, telling the suspect to hand the officer the beer (the suspect kept drinking the beer) then taking the beer away from the suspect. When the suspect refused to take the ticket, the officer gave him the option to either take the citation or go to jail. The suspect took the citation.

**Saturday, July 10, 2010: 0225 hours**

**300 Block E Lakeside Ave – Disorderly - #CD1367122**

Officers observed a male urinating in the alley of 300 Lakeside. He told officers he had been drinking at the **Icon** and **Beacon** earlier that evening.

**Saturday July 10, 2010: 0225 hours**

**N 4<sup>th</sup> St & E Sherman Ave – Protective Custody - #10C19378**

An extremely intoxicated 52 year old woman was taken into protective custody after making statements she wanted to kill herself. Apparently she had been drinking at the **Beacon** and was upset because her date left her for a younger female.

**Saturday July 10, 2010: 0237 hours**

**N 4<sup>th</sup> St & E Lakeside Ave – Disorderly - #CD1367125**

Male warned after being observed urinating on a building at 4<sup>th</sup> & Lakeside. The suspect advised he had been drinking at the **Icon** all night.

**Saturday July 10, 2010: 2315 hours**

**300 Block E Sherman Ave – Alcohol Offense - #10C19485**

A 35 year old male was cited for open container after officers observed him walking on the sidewalk with a beer bottle in his hand. The suspect advised he had brought the beer from his room at the **CDA Resort** and did not know it was against the law (he is from out of state).

**Sunday, July 11, 2010: 0023 hours**

**216 E Coeur d’Alene Ave – Battery - #10C19491**

A 26 year old male was cited at the **Torch** for battery against a 26 year old male, after punching him in the back of head (didn't like him talking to his soon to be exwife) and running from police (on a skateboard). The suspect was located in the alley on 2<sup>nd</sup> St. The female involved in this case was very intoxicated and an additional report was also taken (#10C19495) regarding a possible domestic battery to have occurred between their drinking at the **Icon** earlier that evening and their arrival at the **Torch**.

**Sunday, July 11, 2010: 0125 hours**

**N 4<sup>th</sup> St & E Sherman Ave – Alcohol Offense - #10C19498**

A 23 year old female was cited for open container after officers observed her sitting on the curb of N 4<sup>th</sup> St on the east side of the **Beacon** consuming an alcoholic beverage. The bartender at the **Beacon** confirmed the drink was a Red Bull and Vodka.

Disturbance at the **Icon**. No further information available.

**Sunday, July 11, 2010: 0155 hours**

Disturbance at the **Icon** involving three males. No further information available.

**Monday, July 12, 2010: 0120 hours**

**407 E Sherman Ave – DUI - #CD1367618**

Dispatch received a call of an extremely intoxicated female preparing to get into her silver Audi parked in parking lot behind the **Iron Horse**. The suspect, vehicle and reporting party of call gone when officers arrived.
