Based on recent news accounts, our caucus believes that it is important to investigate potential misconduct in performance of legislative duties by Representative Phil Hart. This formal complaint and request for investigation is as allowed by Rule 76 of the Idaho House of Representatives.

Based on recently disclosed information, it appears that Representative Hart has attempted to use his position as a Member of the Idaho House to obtain special treatment from the Idaho Tax Commission. In addition, as Representative Hart serves on the tax policy committee while at the same time appearing to attempt to set aside tax law and obtain personal financial benefit, there is at the least a perception of a conflict of interest which has not been acknowledged as required by House Rule 38.

I believe it is in all of our best interests--the House, fellow legislators and the citizens of the State--to resolve this issue expeditiously.

The Speaker has selected Representative Thomas Loertscher to chair the seven-member committee and Representative Wendy Jaquet as vice-chair. Other members of the committee include Representatives Dell Raybould, Bert Stevenson, Rich Wills, Bill Killen and George Sayler.

The Speaker indicated no immediate action was necessary from him concerning Rep. Hart's committee assignments, since the committees on which Rep. Hart serves are not scheduled to meet during the interim.

The Speaker stated, "I have full confidence in the Idaho House process and in the capable and experienced members I have selected for this committee. It is important for both the House and for Rep. Hart to have this matter resolved quickly and in a fair, even-handed manner."

The House Ethics Committee will be looking at an August timetable, but the Speaker will leave the exact dates up to Chairman Loertscher to determine with his committee members.
