## INTRODUCTION

The following report was compiled on August 19, 2010 at the request of Captain Childers.

The types of information used to create this report include calls for service, crime reports and field interviews extracted from our Summit database.

Database records were reviewed and compiled based upon both how the record is related to a specific bar or bar activity in general in the downtown Coeur d'Alene area. The following is a table of the establishments and addresses associated with them.

Notably, it is not always possible to obtain information about where a suspect may have been drinking (e.g. too inebriated) or if a particular crime is directly related to a specific establishment. In that context, the **purpose of this report is to provide a general overview of downtown activities in an effort to increase communication between bar establishments and local law enforcement with the final goal of improving public safety.**

**Information on BAC (Blood Alcohol Content) as referenced in this report:**

**State of Idaho BAC DUI Laws:**

- **All drivers** with a **BAC .08** or higher (**enhanced** if **BAC .20** or more)
- **Under 21 years of age** with a **BAC of .02** or higher
- **Commercial Drivers** with a **BAC of .04** or more

**Thursday, August 12, 2010: 2208 hours**  
**E Sherman Ave & S 1<sup>st</sup> St – Fight- #10C23702**

Officers responded to a **fight** call involving 3 people fighting and 15 people standing around watching the fight. A 29 year old male (Spokane Valley) was arrested on an outstanding warrant.

**Friday, August 13, 2010: 2356 hours**  
**320 E Sherman Ave – Disorderly - #10C23843**

Officers cited a 22 year old male for **urinating** in the alleyway. The suspect told the officer he had been drinking at the **Icon** all evening.

**Saturday, August 14, 2010: 0103 hours**  
**216 E Coeur d'Alene Ave – Theft - #CD1377347**

Officers responded to a **theft** call regarding a female who had taken \$100 from a male's wallet while at the **Torch**.

**Saturday, August 14, 2010: 0140 hours**  
**N 5<sup>th</sup> St & E Sherman Ave – Disorderly - #10C23852**

Officers cited a 38 year old male (from Spokane) for **urinating** in public. He had been drinking at the **Iron Horse**.

**Saturday, August 14, 2010: 0155 hours**  
**317 E Sherman Ave – Fight - #10C23853**

Officers responded to a **fight** call at the **Icon** involving three females fighting (pulling hair and punching) and approximately 50 people standing in front of the bar watching the fight. The fight had started earlier on the dance floor in the **Icon** when the suspect female hit another female in the face with a beer bottle. The suspect was asked by bouncers to leave. Later on, outside the bar, the suspect threw another bottle at the victim hitting her in the face, and the fight ensued. The suspect female (19 yrs) was arrested for **battery**.

**Saturday, August 14, 2010: 0228 hours**  
**E Front Ave & N 2<sup>nd</sup> St – Disorderly - #CD1377358**

Officers responded to a **disorderly** call at the **CDA Resort** involving two males who refused to leave and were yelling at resort employees.

**Saturday, August 14, 2010: 0749 hrs**  
**906 E Montana Ave – Unlawful Entry - #10C23866**

Officers responded to an **unlawful entry** call where the suspect (24 year male) was found in a citizen's personal truck parked in front of the citizen's house and a company truck had also been vandalized (side mirror ripped off). The suspect smelled of alcohol and told officers he had been partying the previous night with friends at the **Icon**, had blacked out and had no idea how he had ended up in the vehicle.

**Saturday, August 14, 2010: 2130 hours**  
**317 E Sherman Ave – Fraud - #10C23957**

Officers responded a **fraud** report at the **Beacon** where a female had attempted to use a false identification to enter the bar.

**Saturday, August 14, 2010: 2245 hours**

**216 E Coeur d'Alene Ave – Battery - #CD1377644**

Officers responded to a **battery** call at the **Torch** where a male reported he had been beat up by another male.

**Saturday, August 14, 2010: 2325 hours**

**115 N 2<sup>nd</sup> St – Unwanted Person - #CD1377656**

Officers responded to the **Baja Bargarita** reference an **unwanted person**.

**Sunday, August 15, 2010: 0147 hours**

**216 E Coeur d'Alene Ave – Alcohol - #10C23986**

Officers cited a 34 year old male for **open container** after catching him walking down the street with a pitcher of beer in his hand. At first the suspect denied having the pitcher, and then would not say what bar the pitcher was from, but when the officer gave him the ticket he told the officer he was “not the person who walked out of the **Torch** with a pitcher.”

**Sunday, August 15, 2010: 0221 hours**

**E Lakeside Ave & N 1<sup>st</sup> St – Unconscious - #CD1377694**

Officers received a call reference a male (24 yrs) **passed out in his vehicle**. Downtown security was able to wake him up (intoxicated) and sent him off in a taxi cab.

**Monday, August 16, 2010: 0230 hours**

**115 S 2<sup>nd</sup> St – Theft - #CD1377929**

Officers responded to a **theft** call at the **CDA Resort** reference the theft of liquor.

**Tuesday, August 17, 2010: 0008 hours**

**300 Block E Sherman Avenue – Disorderly - #10C24200**

Officers arrested a 21 year old male for **urinating in public** after the officer observed the suspect doing his business in the flower pot in front of the **Iron Horse**. The suspect had been drinking and was not cooperative with officers.

**Tuesday, August 17, 2010: 0020 hours**

**S 216 E Coeur d'Alene Ave – Unwanted Person - #CD1378220**

Officers responded to an **unwanted person** call reference four females in front of the **Torch** who would not leave when asked. The women were intoxicated and were asked to leave after setting a napkin on fire.

**Tuesday, August 17, 2010: 0230 hours**

**N Ramsey Rd & W Kathleen Ave – DUI - #10C24209**

Officers arrested a 28 year old male for **DUI** after observing him squeal his tires, speed up Kathleen Ave and swerve on the roadway. The driver advised he had been drinking at **Mik & Maccs** earlier in the evening. This was the driver's 3<sup>rd</sup> DUI and he was charged with Felony DUI.
