INTRODUCTION

The following report was compiled on August 11, 2010 at the request of Captain Childers.

The types of information used to create this report include calls for service, crime reports and field interviews extracted from our Summit database.

Database records were reviewed and compiled based upon both how the record is related to a specific bar or bar activity in general in the downtown Coeur d'Alene area. The following is a table of the establishments and addresses associated with them.

Notably, it is not always possible to obtain information about where a suspect may have been drinking (e.g. too inebriated) or if a particular crime is directly related to a specific establishment. In that context, the **purpose of this report is to provide a general overview of downtown activities in an effort to increase communication between bar establishments and local law enforcement with the final goal of improving public safety.**

Information on BAC (Blood Alcohol Content) as referenced in this report:

State of Idaho BAC DUI Laws:

- **All drivers** with a **BAC .08** or higher (**enhanced** if **BAC .20** or more)
- **Under 21 years of age** with a **BAC of .02** or higher
- **Commercial Drivers** with a **BAC of .04** or more

Wednesday, August 4, 2010: 2109 hours

200 E Sherman Ave – Alcohol Offense- #10C22682

Officers cited a 45 year old male for **Open Container** after stopping him from riding his bike on the sidewalk (and causing trouble in the park) and noticing a plastic cup with alcohol (vodka).

Thursday, August 5, 2010: 0142 hours

300 Block E Lakeside Ave – DUI - #10C22696

Officers pulled over a vehicle exiting the **Iron Horse** parking lot after noticing the vehicle did not have its headlights on and the vehicle was swerving down 4th St. The driver, a 27 year old female, was arrested for **DUI (BAC = .130)**.

Officers responded to a **Suspicious Person** call regarding a group of males sitting in a vehicle in the **Iron Horse** parking lot that had dumped garbage out of vehicle, took off, later returned and one of the occupants had urinated on a catering van in the back lot.

Officers responded to a call at the **Iron Horse** where four females tried to leave without paying.

Officers responded to a **stolen vehicle** call, but, the “victim” was not sure where he left it.

Officers responded seven people outside of the **Moose Market** taking pictures.

N 5th St & E Lakeside Ave – Alcohol Offense - #CD1375262

Officers responded to an **alcohol offense**. No further information available.

N 4th St & E Sherman Ave – Alcohol Offense - #10C22956

Officers cited a 28 year old male for **open container** after noticing him standing on the street corner with a beer in his hand. The **Iron Horse** was mentioned in this report.

300 Block E Sherman Ave/Alley – Disorderly - #10C22959

Officers cited a 28 year old male for **urinating in public**. The male told the officers he was walking home after drinking at the **Iron Horse**.

200 Block Coeur d'Alene Ave – Alcohol Offense - #10C22960

Officers cited a 24 year old male for **open container** after noticing him standing in the parking lot of the **Torch** with a bottle of brandy in his hand. The suspect advised it was his bottle of brandy and he was just trying to save some money.

Officers responded to **Petit Theft** at the **CDA Resort** where two males attempted to steal liquor from the pool area. One of the males escaped towards Tubbs Hill.

Officers responded to a **Disorderly** call at the **Icon**. No further information available.

Sunday, August 8, 2010: 0226 hours

100 Block E Sherman Ave – Alcohol Offense - #CD1375593

Officers responded to a very intoxicated female who was found crying in the parking lot of the Bonsai Bistro. She told the officers she had been drinking at the **Icon** that night and her friends had left her there.

Sunday, August 8, 2010: 0212 hours

216 E Coeur d'Alene Ave – Vandalism - #10C23105, #10C23106 & #10C23107

Officers responded to a **vandalism** call at the Torch reference several employees who had found their vehicle vandalized.

Sunday, August 8, 2010: 0335 hours

216 E Coeur d'Alene Ave – Disorderly - #CD1375606

Officers responded a call reference a male passed out in front of the **Torch**. The male told officers he had been drinking at the Torch and “all over.”

Monday, August 9, 2010: 1401 hours

317 E Sherman Ave – Theft - #10C23255

Officers responded to a call regarding the theft of a cell phone from a woman's purse that occurred the previous evening at the **Icon**.

Tuesday, August 10, 2010: 0200 hours

S 7th St & E Front Ave – False ID - #10C23327

Officers responded to a call reference a group of people who left the **Shore Lounge** without paying their tab. Officers located the suspects (who were intoxicated) and arrested one underage female (20 years old) for alcohol and false identification charges. The female was heavily intoxicated, could not stand or walk on her own and due to her non-stop vomiting (in the back of the police car), she was taken to KMC for medical attention.

Tuesday, August 10, 2010: 0030 hours

216 E Coeur d'Alene Ave – Grand Theft - #10C23338

Officers responded to a **Grand Theft** call reference a purse that was stolen from the **Torch** (left it on a chair while visiting the restroom). The purse was later located on Interstate 90 (might have been ran over).

Wednesday August 11, 2010: 0203 hours

407 E Sherman Ave – Fight - #10C23452

Officers responded to a **Fight** call reference five males who had started fighting on the sidewalk near the **Iron Horse** and later moved down the street continuing the fight on the corner near the **Beacon**. According to witnesses, three males (ages 21, 21, & 23) ganged up on another male outside of the Iron Horse and three older males (from out of town) intervened. The three suspects (who were intoxicated) were cited for fighting in public and the victim (who had run) could not be located.
