# Coeur d'Alene Police Dept Downtown Bar Report

## INTRODUCTION

The following report was compiled on July 28, 2010 at the request of Captain Childers. The types of information used to create this report include calls for service, crime reports and field interviews extracted from our Summit database.

Database records were reviewed and compiled based upon both how the record is related to a specific bar or bar activity in general in the downtown Coeur d'Alene area. The following is a table of the establishments and addresses associated with them.

Notably, it is not always possible to obtain information about where a suspect may have been drinking (e.g. too inebriated) or if a particular crime is directly related to a specific establishment. In that context, the purpose of this report is to provide a general overview of downtown activities in an effort to increase communication between bar establishments and local law enforcement with the final goal of improving public safety.

Information on BAC (Blood Alcohol Content) as referenced in this report:

#### State of Idaho BAC DUI Laws:

- All drivers with a BAC .08 or higher (enhanced if BAC .20 or more)
- Under 21 years of age with a BAC of .02 or higher
- Commercial Drivers with a BAC of .04 or more

## Thursday, July 22, 2010: 2312 hours

## 4<sup>th</sup> & Sherman Ave – Alcohol Offense- #10C20982

Officers cited a 45 year old male for **Open Container** after observing him on the corner of 4<sup>th</sup> & Sherman with a beer bottle in his hand. The offender was not from the Coeur d'Alene area.

## 216 E Coeur d'Alene Ave - Disorderly - #10C20989

Two males (28 & 30 years of age) were cited for **Urinating in Public** after officers noticed a group of 4 -5 persons in the **Torch** parking lot looking toward the alley. Upon approaching the alley, the officers contacted a male who was intoxicated and showed officers where he had urinated in the alley. Officers had observed a second male in the act and he was cited as well.

Officers responded to a **Domestic Dispute** call (male versus female) at the **Icon**. No further information available.

## N 4<sup>th</sup> St & E Sherman Ave – Disorderly - #10C21115

Officers cited a 24 year old male for Urinating in Public.

Officers responded to an **Intoxicated** male who was vomiting and passed out. Medical was called. The male had been seen earlier drinking at the **Icon**.

Officers responded to **Fight** call at 4<sup>th</sup> & Sherman involving 15 people fighting and a lot people crowding around them. No further information available.

## 407 E Sherman Ave – Disorderly - #10C21133

Officers arrested a 35 year old male on a **Warrant** and cited him for **Urinating in Public** after observing him in the alley behind the **Iron Horse**.

Officers responded to an **Alcohol** offense at **Iron Horse**. No further information available.

Officers cited a 24 year old male for **Open Container** after observing him drink vodka from a glass outside of a bar. The source of the vodka appears to be a bottle in the back of his friend's vehicle.

Officers responded to an Alcohol offense. No further information available.

## Sunday, July 25, 2010: 0029 hours

## N 3<sup>rd</sup> St & E Sherman Ave – Resisting - #10C21248

Officers noticed a large crowd begin to form at the door of the **Icon** and as they approached noticed approximately 20 people exit the bar and bouncers fighting with multiple males. Although officers gave verbal commands to stop, the crowd (which had grown to 30 – 35 people) did not listen and continued to fight. With the assistance of bouncers, officers had to tackle one male to the ground before he would comply. Another male (26 years of age) was belligerent with officers, interfering with their attempts to speak with the others involved with the dispute and insisting that the officers needed to arrest the bouncer from the **Icon**—after several warnings, this male was arrested for **Obstructing an Officer**.

## **Sunday, July 25, 2010: 0033 hours**

## N 3<sup>rd</sup> St & E Lakeside Ave – DUI - #10C21249

Officers were flagged down by a group of people reference a person who was attempting to leave the scene of an accident. Upon arrival, the officers noticed a vehicle with two occupants and a downed motorcycle and medical was called to the scene. The driver of the vehicle, a 22 year old female, was arrested for **Aggravated DUI (BAC = .204)**. The suspect admitted that she had been drinking at the **Iron Horse**, **Shore Lounge and Icon** ("Trash Cans" and beer) earlier that evening.

## CDA Resort Dock-Welfare Check - #CD1371414

Officers responded to the **CDA Resort** Docks reference an intoxicated male (40 - 50) years of age) who had fallen into the water and was unable to get out. A few minutes later the male was out of the water and flopping around on the dock (because he was so intoxicated). No further information available.

Officers requested a patient evaluation for a split lip in front of the **Icon**.

Officers responded to an **Intoxicated** (and angry male) in front of the Pita Pit who was upset because police had arrested his cousin and were telling him what to do.

## 400 Block E Lakeside Ave - DUI - #10C21610

A 27 year old male was arrested for **DUI (BAC = .167)** after officers noticed him passed out in the driver's seat of his parked vehicle. The suspect advised he had been drinking at several bars that evening—the last being the **Iron Horse**.

Officers arrested a 39 year old female and 52 year old male on **Drug** charges. The two were in a van in the **Iron Horse** parking lot (being stalked by her exboyfriend).
