

On at least two occasions, June 23 and July 14 2010, Thomas Jarrard, the Campaign Manager for Shelly O'Quinn's campaign, has sent out emails citing "recent polling" data indicates O'Quinn is "beating the competition" or "blowing the competition away" However the most current PDC indicates no expenditure for polling. Political polls are an expensive venture, and an in-kind contribution or and expenditure for the receipt of such valuable data should be listed.

This is in violation of RCW 42.17.080 (2(c))

Additionally Thomas Jarrard has posted identical comments on the Spokane County Republican Party Facebook page. When researching for this complaint, I found those posts have been deleted.

Separately, the O'Quinn has a large billboard located near the Corner of Washington and Sprague, in Spokane WA. There does not appear to be a PDC expenditure or in-kind contribution for this advertizing as well.

This is also in violation of RCW 42.17.080 (2(c))
