INTRODUCTION

The following report was compiled on Sept. 30, 2010 at the request of Captain Childers. The types of information used to create this report include calls for service, crime reports and field interviews extracted from our Summit database.

Database records were reviewed and compiled based upon both how the record is related to a specific bar or bar activity in general in the downtown Coeur d'Alene area. The following is a table of the establishments and addresses associated with them.

Notably, it is not always possible to obtain information about where a suspect may have been drinking (e.g. too inebriated) or if a particular crime is directly related to a specific establishment. In that context, the **purpose of this report is to provide a general overview of downtown activities in an effort to increase communication between bar establishments and local law enforcement with the final goal of improving public safety.**

Information on BAC (Blood Alcohol Content) as referenced in this report:

State of Idaho BAC DUI Laws:

- **All drivers** with a **BAC .08** or higher (enhanced if **BAC .20** or more)
- **Under 21 years of age** with a **BAC of .02** or higher
- **Commercial Drivers** with a **BAC of .04** or more

Friday, September 24, 2010: 2220 hours

400 Block Sherman Ave – Alcohol Offense #10C28628

Officers cited a male (21 yrs of age) for **open container** after finding him sitting near a statue with a bottle of liquor. The male stated he was homeless.

Friday, September 24, 2010: 2234 hours

407 E Sherman Ave – Unwanted Person - #CD1388187

Officers responded to the **Iron Horse** reference an **unwanted person**. The male was refusing to pay, and he needed to be trespassed from the bar.

Friday, September 24, 2010: 2253 hours

N 3rd St & E Sherman Ave – Alcohol Offense - #CD138194

Officers responded to an **alcohol call**. No further information available.

Friday, September 24, 2010: 2301 hours

N 4th St & E Sherman Ave – Alcohol Offense - #CD1388197

Officers responded to an **alcohol call**. No further information available.

Saturday, September 25, 2010: 0158 hours

N 3rd St & E Sherman Ave – Disorderly - #CD1388232

Officers responded to an intoxicated female in the roadway. No further information available.

Saturday, September 25, 2010: 2233 hours

2300 Block N 4th St –DUI - #10C28734

Officers charged two brothers (24 & 26 yrs) at Denny's: One was cited for **fighting in a public place** and the other arrested for **DUI**. Apparently the two had been drinking at the **Torch Lounge** celebrating a birthday. They left the bar and stopped at Denny's for a drink of water. Both brothers were intoxicated and the reason for the fight is unknown. The brother who had driven them was arrested for **DUI (BAC = .206)**. He indicated they had consumed four pitchers of beer that evening.

Sunday, September 26, 2010: 0015 hours

300 Block E Sherman Ave – Disorderly - #10C28747

Officers cited a 25 year old male (from California) for **urinating in public** after watching him walk in front of cars in the crosswalk and then stop to do his business near a dumpster.

Sunday, September 26, 2010: 0101 hours

204 S 3rd St (3rd St Parking Lot) – Alcohol Offense - #CD1388454

Officers were involved in an **alcohol offense** in the **3rd St Parking Lot**. No further information available.

Sunday, September 26, 2010: 0243 hours

N 11th St & E Indiana Ave – Hit & Run Accident - #10C28755

Officers responded to a **Hit & Run Accident** where the suspect vehicle had blown a stop sign and hit another vehicle in the intersection. Officers followed vehicle fluid from the suspect vehicle to a local motel and located the suspects, a 34 year old male (from Oregon) and a 26 year old female (from Sandpoint). Both were intoxicated and unwilling to admit who had driven the vehicle. Both were arrested for **leaving the scene of an accident** pending further investigation.

Sunday, September 27, 2010: 1551 hours

407 E Sherman Ave – Theft - #10C28921

A 40 year old female reported her wallet had been stolen the previous evening while she was at the **Iron Horse**. She stated her purse was on the floor, and she had only left it there for a few minutes, but when she returned her wallet was missing.

Monday, September 28, 2010: 0128 hours

800 Block E Lakeside Ave – DUI - #10C28976

After noticing a vehicle almost hitting parked vehicles, officer pulled over and arrested a male (39 yrs) for **DUI (BAC = .114)** The male told officers he had two 16 ounce “Blue Moons” at the **Moose** earlier in the evening.
