INTRODUCTION

The following report was compiled on October 6, 2010 at the request of Captain Childers.

The types of information used to create this report include calls for service, crime reports and field interviews extracted from our Summit database.

Database records were reviewed and compiled based upon both how the record is related to a specific bar or bar activity in general in the downtown Coeur d'Alene area. The following is a table of the establishments and addresses associated with them.

Notably, it is not always possible to obtain information about where a suspect may have been drinking (e.g. too inebriated) or if a particular crime is directly related to a specific establishment. In that context, the purpose of this report is to provide a general overview of downtown activities in an effort to increase communication between bar establishments and local law enforcement with the final goal of improving public safety.

Friday, October 1, 2010: 2334 hours

216 E Coeur d'Alene Ave – Citizen Assist #10C28628

Officers responded to a **citizen assist** call at the **Torch Lounge** reference bouncers confiscating a possible fake ID.

Saturday, October 2, 2010: 0029 hours

N 2nd St & E Lakeside Ave - Fight - #CD1388971

Officers responded to **fight** call in front of the **Baja Bargarita** reference two males and two females. The suspects appeared to have left walking toward Lakeside and the fight started once more. The suspects were gone on arrival of law enforcement.

Officers arrested a 47 year old male (from Washington) at the **Torch Lounge** for **DUI** after receiving an anonymous call reference two motorcyclists that had been drinking and were now leaving on their motorcycles.

According to the female victim, she had left the purse on a ledge in the alley to go to the restroom and when she returned the purse was gone. Later some of the items were recovered in the alleyway.

Officers responded to an **unwanted person** call at the **Torch Lounge** reference an intoxicated male who had been kicked out several times and would not stay outside.

Officers responded to a **fight** call near the **Moose Market** involving a group of twenty persons.

Officers responded to a **battery** call at the **Iron Horse** reference a 28 year old male who had punched the bartender in the face (didn't like his girlfriend liking the bartender).

320 E Sherman Ave – Unwanted Person – #CD1390239

Officers responded to a call at the **Pita Pit** reference an intoxicated male who was refusing to leave.

Sunday, October 3, 2010: 0839 hours 407 E Sherman Ave – **Battery** - #10C29623

Officers responded to a cold **battery** calls reference an incident that had occurred the previous evening at the **Iron Horse.** According to the victim (36 year old male from Washington), he was standing outside the bar with friends and observed a male and a female who was vomiting. One of the females in the victim's party made an inappropriate comment, an argument ensued and the suspect head butted the victim (requiring stitches).

Wednesday, October 6, 2010: 0052 hours 115 S 2nd St – **Mal Injury** - #10C29902

Officers responded to a **malicious injury to property** call at the **Coeur d'Alene Resort** reference an extremely intoxicated guest (from California) who had thrown patio furniture over the balcony (12th floor). The officers intended to issue the suspect a misdemeanor citation for malicious injury to property until he spit a mouth full of Pringles potato chips at a police officer. The suspect was then arrested for **battery.**
