## INTRODUCTION

The following report was compiled on October 15, 2010 at the request of Captain Childers.

The types of information used to create this report include calls for service, crime reports and field interviews extracted from our Summit database.

Database records were reviewed and compiled based upon both how the record is related to a specific bar or bar activity in general in the downtown Coeur d'Alene area. The following is a table of the establishments and addresses associated with them.

Notably, it is not always possible to obtain information about where a suspect may have been drinking (e.g. too inebriated) or if a particular crime is directly related to a specific establishment. In that context, the **purpose of this report is to provide a general overview of downtown activities in an effort to increase communication between bar establishments and local law enforcement with the final goal of improving public safety.**

**Information on BAC (Blood Alcohol Content) as referenced in this report:**

**State of Idaho BAC DUI Laws:**

- **All drivers** with a **BAC .08** or higher (**enhanced** if **BAC .20** or more)
- **Under 21 years of age** with a **BAC of .02** or higher
- **Commercial Drivers** with a **BAC of .04** or more

**Wednesday, October 6, 2010: 2343 hours**

**N 5<sup>th</sup> St & E Sherman Ave – Disorderly #10C30006**

Officers cited an intoxicated 26 year old male for **urinating in public**.

**Thursday, October 7, 2010: 0042 hours**

**200 Block E Sherman Ave – Fight - #CD1391185**

Officers responded to **fight** call on the 200 block of Sherman. Participants gone on arrival. No further information available.

**Thursday, October 7, 2010: 0129 hours**

**216 E Coeur d'Alene Ave – Unwanted Person - #CD1391188**

Officers responded to an **unwanted person** call at the **Torch Lounge** reference two males. Apparently the two had been involved a fight earlier and were refusing to leave.

**Thursday, October 7, 2010: 0213 hours**

**407 E Sherman Ave – DUI - #10C30007**

Officers arrested a 34 year old male for **DUI** after observing the driver drive up on the sidewalk while making a turn. The suspect was uncooperative and belligerent with officers.

**Friday, October 8, 2010: 2236 hours**

**N 1<sup>st</sup> St & E Lakeside Ave – DUI - #10C30193**

Officers arrested a 21 year old male for **DUI**. According to the suspect he had one beer at the **Iron Horse (BAC = .167)**.

**209 E Sherman Ave – Fight - #CD1391707**

Officers responded to the **Eagles Lodge** reference a **fight** call. The call was unfounded.

**Saturday, October 9, 2010: 0026 hours**

**N 3<sup>rd</sup> St & E Sherman Ave – Fight - #CD1391725**

Officers responded to a **fight** call involving a large crowd where several males and females both yelling and physically fighting. No further information available.

**Saturday, October 9, 2010: 2237 hours**

**N 3<sup>rd</sup> St & E Sherman Ave – Unconscious - #CD1391946**

Officers responded to call reference two females who had passed out from intoxication at the **Eagles Lodge**.

**Saturday, October 9, 2010: 2250 hours**

**407 E Sherman Ave – Battery – #10C30279**

Officers responded to a **battery** call at the **Iron Horse** reference a bouncer who had been injured by a female. Apparently the female and her boyfriend were asked to leave the bar several times and at one point the female took a swing at the bouncer. Notably the female was very intoxicated and required the assistance of two officers to exit the bar (while screaming obscenities). After further belligerent behavior (including trying to kick the windows out of the patrol car), the 46 female was arrested for **battery** and **obstructing a police officer**.

**400 Block E Lakeside – Disorderly - #10C30280**

Officers cited a 35 year old male (from Washington) for **urinating in public**. The man told officers he had just leave the **Iron Horse**.

**N 2<sup>nd</sup> St & E Sherman Ave – Fight - #CD1391967**

Officers responded to a **fight** call at the **Torch Lounge** reference four girls fighting in the bar. No further information available.

Officers responded to a **disorderly** call. No further information available.

**Sunday, October 10, 2010: 0129 hours**

**407 E Sherman Ave – Welfare Check - #CD1391971**

**Disorderly** call was received by Dispatch. Reporting party called back and said it was regarding a fight at the **Iron Horse** that had been resolved.

**Sunday, October 10, 2010: 0141 hours**

**317 E Sherman Ave – Unconscious- #CD1391974**

Officers responded to a call reference a 22 year old female sitting in a wheelchair outside the **Icon** unconscious and vomiting. Subjects may have mixed medications with alcohol.

**N 3<sup>rd</sup> St & E Coeur d'Alene Ave – Traffic Offense - #CD1391978**

Officers responded to a call reference a vehicle driving the wrong way up 3<sup>rd</sup> St. No further information available.

**208 W Appleway Ave – DUI - #10C30296**

Officers arrested a 22 year old female for **DUI** after she was noticed sitting in her vehicle in the McDonalds parking lot. According to the suspect, she had pulled over because she was too intoxicated to drive. She told officers she had been drinking at the **Icon (BAC = .246)** prior to pulling over to wait for a friend to pick her up.
