INTRODUCTION

The following report was compiled on November 17, 2010 at the request of Captain Childers.

The types of information used to create this report include calls for service, crime reports and field interviews extracted from our Summit database.

Database records were reviewed and compiled based upon both how the record is related to a specific bar or bar activity in general in the downtown Coeur d'Alene area. The following is a table of the establishments and addresses associated with them.

Notably, it is not always possible to obtain information about where a suspect may have been drinking (e.g. too inebriated) or if a particular crime is directly related to a specific establishment. In that context, the **purpose of this report is to provide a general overview of downtown activities in an effort to increase communication between bar establishments and local law enforcement with the final goal of improving public safety.**

Information on BAC (Blood Alcohol Content) as referenced in this report:

State of Idaho BAC DUI Laws:

- **All drivers** with a **BAC .08** or higher (**enhanced** if **BAC .20** or more)
- **Under 21 years of age** with a **BAC of .02** or higher
- **Commercial Drivers** with a **BAC of .04** or more

Thursday, November 11, 2010: 0049 hours

216 E Coeur d'Alene Ave – Fight - #CD1400943

Officers responded to a **fight** call in front of the **Torch Lounge** reference a large group physically fighting. No further information available.

Thursday, November 11, 2010: 0118 hours

216 E Coeur d'Alene Ave – Battery - #10C33460

Officers responded a cold **battery** call that had occurred a few hours earlier at the **Torch Lounge** involving a female and male. The two were no longer dating; however, a fight ensued and the women later received medical care (concussion).

Thursday, November 11, 2010: 0104 hours

216 E Coeur d'Alene Ave – Fight - #CD1401213

Officers responded to a **fight** call at the **Torch Lounge** involving four males. No further information available.

Friday, November 12, 2010: 2359 hours

317 E Sherman Ave – Fight - #CD1401479

Officers responded to a **fight** call at the **Beacon** involving two males physically fighting and other people getting involved. No further information available.

Saturday, November 13, 2010: 0016 hours

301 E Sherman Ave – DUI - #10C33641

Officers arrested two males for **DUI (BAC = .191)**. A witness had noticed one of the males driving his truck the wrong way on 3rd Street, turn into the bank and hit the ATM. The second male (also intoxicated) saw the crashed vehicle and hopped in the driver's seat in an attempt to move the vehicle. Both males were arrested. One male admitted drinking at the **Icon**.

Saturday, November 13, 2010: 0112 hours

N 3rd St & E Lakeside Ave – DUI - #10C33645

Officers arrested a 21 year old female for **DUI (BAC - .191)** after pulling her over (driving the wrong way down 3rd Street). The female admitted to drinking three shots at the **Icon** earlier that evening. When asked why she was driving the wrong way down 3rd, she told the officer she "always forgets."

Saturday, November 13, 2010: 0140 hours

317 E Sherman Ave – Theft Grand - #10C33640

Officers were contacted by a 23 year old female who reported her purse had been stolen earlier at the **Icon**. According to the victim, she had left her purse at a table with her "friends," and the suspect female approached the table, asked for the purse (saying it was hers) and walked off with it.

317 E Sherman Ave – Theft - #CD1401498

Officers received a theft call reference a cell phone stolen at the **Icon**. According to the caller, the suspects called her mom's phone and told her mom they were making a drug deal. She was advised to file her report online.

N 3rd St & E Coeur d'Alene Ave – Auto Burglary - #CD1401499 & #163112

Officers responded to an **auto burglary in progress** call and upon arrival found three intoxicated males. Although the officer told one of the males to sit at the base of a concrete wall near the alley (not on top of the wall), the male stated he had “no problem with falling” and sat on the top of the wall. He fell (five feet), hit his head and was knocked unconscious. When the male regained consciousness, he came up swinging at the officer. Medical was called and he was transported to KMC to be evaluated.

N 4th St & E Sherman Ave – Disturbance - #CD1401695

Officers responded to a **disturbance** call. No further information available.

Monday, November 14, 2010: 0125 hours

317 E Sherman Ave – Seizure - #CD1401696

Officers responded to a call reference a female outside the **Icon** who was in seizure and now unconscious and not breathing. When officers arrived the female was conscious and alert. Medical was called. No further information available.

Officers responded to a **disturbance** at the **Icon** reference a **fight**. No further information available.
