INTRODUCTION

The following report was compiled on November 30, 2010 at the request of Captain Childers.

The types of information used to create this report include calls for service, crime reports and field interviews extracted from our Summit database.

Database records were reviewed and compiled based upon both how the record is related to a specific bar or bar activity in general in the downtown Coeur d'Alene area. The following is a table of the establishments and addresses associated with them.

Officers responded to a **fight** call at the **lcon**. No further information available.
