## INTRODUCTION

This report was compiled on December 28, 2010 at the request of Captain Childers.

The types of information used to create this report include calls for service, crime reports and field interviews extracted from our Summit database.

Database records were reviewed and compiled based upon both how the record is related to a specific bar or bar activity in general in the downtown Coeur d'Alene area. The following is a table of the establishments and addresses associated with them.

Notably, it is not always possible to obtain information about where a suspect may have been drinking (e.g. too inebriated) or if a particular crime is directly related to a specific establishment. In that context, the **purpose of this report is to provide a general overview of downtown activities in an effort to increase communication between bar establishments and local law enforcement with the final goal of improving public safety.**

**Information on BAC (Blood Alcohol Content) as referenced in this report:**

**State of Idaho BAC DUI Laws:**

- **All drivers** with a **BAC .08** or higher (**enhanced** if **BAC .20** or more)
- **Under 21 years of age** with a **BAC of .02** or higher
- **Commercial Drivers** with a **BAC of .04** or more

**Friday, December 10, 2010: 1723 hours**

**N 4<sup>th</sup> St & E Harrison Ave – Hit & Run / DUI - #10C36230**

Officers responded to a report of a **Hit & Run** vehicle that had sideswiped a light pole. Officers located the suspect vehicle and arrested a 31 year old female for felony **DUI (her 3<sup>rd</sup> DUI)**. The female told officers her last drink was a double vodka tonic at the **Iron Horse**.

**Saturday, December 11, 2010: 2332 hours**

**N 8<sup>th</sup> St & E Garden Ave – DUI - #10C36332**

Officers arrested a 43 year old male for **DUI** after a routine traffic stop (failed to stop at stop sign). The suspect advised he had a couple of drinks at the **Iron Horse**.

**Monday, December 13, 2010: 0041 hours**

**Northwest Blvd & Lacrosse Ave – DUI - #10C36405**

Officers arrested a 26 year old male for **DUI (BAC = .229)** after a routine traffic stop (speeding & without headlights on). According to the male, he had consumed a couple of drinks downtown (**Beacon & Iron Horse**), but later admitted he was not sure how many drinks he had consumed.

**Wednesday, December 15, 2010: 2216 hours**

**115 S 2<sup>nd</sup> St – Fight - #CD1410344**

Officers responded to a physical **fight** call at the **Coeur d'Alene Resort** involving a 24 year old male hitting an employee. The male was tracked down to the **Iron Horse**, where the subject started another fight. The victims did not want to press charges, and the male was trespassed from both locations.

**Thursday, December 16, 2010: 0035 hours**

**216 E Coeur d'Alene Ave – Battery - #CD1410365**

Officers responded to a physical **fight** call at the **Torch Lounge** involving two males where one male hit another and then was thrown out through the back door. Upon arrival, officers were unable to locate either victim or suspect.

**Thursday, December 16, 2010: 0145 hours**

**117 N 2<sup>nd</sup> St – Battery / Domestic - #10C36742**

Officers responded to a **fight** call outside the **Baja Bargarita** involving a male and female. Both were intoxicated and had been arguing. During the altercation, the male had slapped the female. The male was arrested for **domestic battery**.

**Thursday, December 16, 2010: 0200 hours**

**115 S 2<sup>nd</sup> St – Battery - #10C36743**

Officers responded to a **battery** call at the **Coeur d'Alene Resort** involving two females (36 and 22 years of age). According to one of the females, the fight started outside the **Baja Bargarita** and when one of the females tried to get away, the other female followed her until she went into the Coeur d'Alene Resort and asked Security for assistance. Both females were intoxicated and one was cited for **battery**.

**Friday, December 17, 2010: 2220 hours**

**115 S 2<sup>nd</sup> St – Suicide Threat - #CD1410987**

Officers responded to the **Coeur d'Alene Resort** reference a highly intoxicated woman threatening suicide. The woman had been attending a company party. Medical was called to evaluate her, and a family member picked her up.

**Saturday, December 18, 2010: 0116 hours**  
**N 4<sup>th</sup> St & E Sherman Ave – Disorderly - #CD1411013**

Officers responded to a **disorderly** call reference a male harassing his ex-girlfriend outside the **Beacon**. The suspect was gone on arrival.

**317 E Sherman Ave – Fight - #CD1411014**

Officers responded to a **fight** call involving a large group of people fighting inside the **Icon**. No further information available.

Officers responded to a **fight** call outside the **Pita Pit**. Subjects were gone on arrival. No further information available.

**Saturday, December 18, 2010: 0214 hours**  
**300 Block E Sherman Ave – DUI - #10C36974**

Officers arrested a 37 year old male for **DUI (BAC = .109)** after watching him walking and stumbling on the sidewalk in front of the **Beacon**. The officer intercepted the male after he entered the driver's side of his vehicle. A marijuana pipe was found in the vehicle as well.

**Sunday, December 19, 2010: 0043 hours**  
**300 Block Sherman Ave – Disorderly - #10C37084**

Officers observed and cited a 26 year old male for **urinating in public** in the alley behind the **Icon**. The male was intoxicated and admitted to have been drinking downtown and at the **Icon**.

**Northwest Blvd & W Hubbard Ave – DUI - #10C37086**

Officers arrested a 29 year old female for **DUI (BAC=.149)** after observing her driving erratically (hitting curb). The female told officers she had two glasses of wine at a party and part of a glass of beer at the **Iron Horse**.

**300 Block E Lakeside Ave – DUI - #10C37575**

Officers arrested a 34 year old female for **DUI** after a routine traffic stop. The female admitted to drinking a beer at the **Iron Horse** prior to driving.

Officers observed a 31 year old male punch another male (41 years old) in front of the **Torch Lounge**. Apparently the older male was intoxicated and made lewd comments to the younger male's wife.

**N 5<sup>th</sup> St & E Sherman Ave – Welfare Check - #CD1412689**

Officers responded to a call reference a male in a vehicle who appeared to be sleeping but may have vomited on himself. No further information available.

Officers arrested a 57 year old male for **DUI (BAC=.147)** after finding him asleep in his running car.

Officers arrested a 21 year old male for **DUI** after a routine traffic stop. The male told the officer he had a drink at home that evening and later a few beers at the **Moose Lounge**.
