# INTRODUCTION

This report was compiled on January 21, 2011 at the request of Captain Childers.

The types of information used to create this report include calls for service, crime reports and field interviews extracted from our Summit database.

Database records were reviewed and compiled based upon both how the record is related to a specific bar or bar activity in general in the downtown Coeur d'Alene area. The following is a table of the establishments and addresses associated with them.

Notably, it is not always possible to obtain information about where a suspect may have been drinking (e.g. too inebriated) or if a particular crime is directly related to a specific establishment. In that context, the purpose of this report is to provide a general overview of downtown activities in an effort to increase communication between bar establishments and local law enforcement with the final goal of improving public safety.

- All drivers with a BAC .08 or higher (enhanced if BAC .20 or more)
- Under 21 years of age with a BAC of .02 or higher
- Commercial Drivers with a BAC of .04 or more

# Saturday, January 15, 2011: 0008 hours

## 317 E Sherman Ave – Fall - #CD148193

Officers responded to a call reference an extremely intoxicated female (20's) who had fallen and hit her head in the alley behind the **Icon.** Medical was called. No further information available.

## Saturday, January 15, 2011: 0100 hours

#### 320 E Sherman Ave – Disorderly - #11C01253

Officers responded to the **Pita Pit** in regard to an extremely intoxicated male. The male (22 years) was arrested on a prior warrant for **Disturbing the Peace**. No further information available.

## Saturday, January 15, 2011: 0208 hours

#### 320 Block Sherman Ave – Disorderly - #11C01257

Officers observed and responded to two males (21 & 23 years) fighting in front of the **Icon**. The argument was diffused; however, one of the males continued the disturbance by egging on bouncers at the **Icon** and challenging them to fight. The offending male was cited for **disturbing the peace**.

# 115 N 2<sup>nd</sup> St - False ID - #CD1418398

Officers responded to the **Baja Bargarita** in regard to a possible **false ID**. Officers determined the identification to be valid. No further information available.

# Saturday, January 15, 2011: 2122 hours

# 700 Block of N 3rd St - Unlawful Entry - #11C01329

Officers responded to a **burglary in progress** at a residence in the 700 block of 3<sup>rd</sup> St. The occupants of the home (a 52 babysitter and two children) had locked themselves in an upstairs bedroom after seeing a strange male enter the house and shut himself in the office. Officers arrived and found a 19 year old male passed out on the office floor. The male was very intoxicated and did know where he was. The male was arrested for **unlawful entry**.

# Saturday, January 15, 2011: 2228 hours

# 115 S 2<sup>nd</sup> St - DUI - #11C01333

Officers arrested a 25 year old male for **DUI (BAC = .235)** in the **Coeur d'Alene Resort** parking garage after responding to a **hit & run accident** report. The suspect claimed he had been drinking at the **Shore Lounge** and his "designated driver" was really the one who hit the parked vehicle, but fled the scene before security arrived. The male stated that after his "friend" left him, he moved into the driver's seat, started to drive and was detained by security. The suspect did not have a lot of information about his designated driver / accident causing friend and was arrested on **DUI** charges.

## 216 E Coeur d'Alene Ave – Battery - #CD1418426

Officers responded to the **Rendezvous (aka Torch Lounge)** in regard to a female who had been **battered** by another female. The victim claimed she used to dance at the bar and it unknown what the fight was about. The victim was gone on arrival and no further information is available.

# Sunday, January 16, 2011: 0313 hours

## 320 E Sherman Ave – Fight - #CD1418452

Officers responded to a **fight** call involving two males in the parking area near the **Pita Pit.** The officers made contact with the victim who told them he did not know the suspect, did not require medical, and did not want to press charges. No further information available.
