INTRODUCTION

This report was compiled on January 7, 2011 at the request of Captain Childers.

The types of information used to create this report include calls for service, crime reports and field interviews extracted from our Summit database.

Database records were reviewed and compiled based upon both how the record is related to a specific bar or bar activity in general in the downtown Coeur d'Alene area. The following is a table of the establishments and addresses associated with them.

Notably, it is not always possible to obtain information about where a suspect may have been drinking (e.g. too inebriated) or if a particular crime is directly related to a specific establishment. In that context, the **purpose of this report is to provide a general overview of downtown activities in an effort to increase communication between bar establishments and local law enforcement with the final goal of improving public safety.**

Information on BAC (Blood Alcohol Content) as referenced in this report:

State of Idaho BAC DUI Laws:

- **All drivers** with a **BAC .08** or higher (enhanced if **BAC .20** or more)
- **Under 21 years of age** with a **BAC of .02** or higher
- **Commercial Drivers** with a **BAC of .04** or more

Friday, January 7, 2010: 2237 hours

407 E Sherman Ave – Domestic Dispute - #CD1416516

Officers responded to a call reference a male pushing a female through a window. Medical was called for a laceration on the female's back. No further information available.

Saturday, January 8, 2010: 0020 hours

200 Block E Coeur d'Alene Ave – DUI - #11C00655

Officers arrested a 25 year old female for **DUI** after noticing her driving the wrong way down 3rd St. She had consumed a couple of beers at the **Torch** that evening.

Saturday, January 8, 2010: 0221 hours

N 3rd St & E Lakeside Ave – DUI - #11C00662

Officers arrested a 25 year old male for **DUI** after noticing him pull out and start to drive the wrong way down 3rd St. He had been drinking at downtown bars that evening.

Saturday, January 8, 2010: 0300 hours

301 E Sherman Ave – DUI - #11C00665

Officers noticed a 29 year old male littering and spoke with him. The male admitted he was intoxicated and when officers asked how he was getting home that evening, he told them by taxi; however, after the officers left, the male jumped in his vehicle and attempted to drive. He was arrested for **Excessive DUI (BAC=.228)**. He had been drinking at the **Icon** that evening.

Sunday, January 9, 2010: 0023 hours

N 3rd St & E Sherman Ave – Fight - #CD1416801

Officers responded to a **fight** call involving 10 people fighting outside. The two groups dispersed prior to law enforcement contact. No further information available.

Friday, January 14, 2010: 0249 hours

S 15th ST & E Front Ave – DUI - #11C01187

Officers arrested a 33 year old male for **DUI (BAC = .105)** after a routine traffic stop. The male admitted to drinking three beers and two shots of Tequila at the **Iron Horse** that evening.
