## INTRODUCTION

This report was compiled on February 28, 2011 at the request of Captain Childers.

The types of information used to create this report include calls for service, crime reports and field interviews extracted from our Summit database.

Database records were reviewed and compiled based upon both how the record is related to a specific bar or bar activity in general in the downtown Coeur d'Alene area. The following is a table of the establishments and addresses associated with them.

Notably, it is not always possible to obtain information about where a suspect may have been drinking (e.g. too inebriated) or if a particular crime is directly related to a specific establishment. In that context, the **purpose of this report is to provide a general overview of downtown activities in an effort to increase communication between bar establishments and local law enforcement with the final goal of improving public safety.**

**Information on BAC (Blood Alcohol Content) as referenced in this report:**

**State of Idaho BAC DUI Laws:**

- **All drivers** with a **BAC .08** or higher (enhanced if **BAC .20** or more)
- **Under 21 years of age** with a **BAC of .02** or higher
- **Commercial Drivers** with a **BAC of .04** or more

**Friday, February 18, 2011: 0034 hours**

**900 Block N 5<sup>th</sup> St – DUI - #11C04405**

Officers responded to a call reference an **unconscious** female in the roadway. Upon arrival they contacted the female who admitted to jumping out of a moving vehicle (she thought the vehicle was moving slower than it actually was). The female was part of a group of intoxicated people driving two different vehicles. During the investigation of this incident, officers contacted and arrested a 23 year old male for **DUI (BAC = .153)**. The male told officers he had been drinking at **Crickets** earlier in the evening.

**N 4<sup>th</sup> St & E Sherman Ave – Alcohol Offense - #11C04509**

Officers cited a 21 year old male for **Open Container** after observing the male walking down the street holding a can of beer.

**Friday, February 18, 2011: 2343 hours**

**100 Block N 4<sup>th</sup> St – Disorderly - #11C04511**

Officers arrested an intoxicated 21 year old male for **urinating in public**.

**Friday, February 18, 2011: 2350 hours**

**317 E Sherman Ave – Disturbance - #CD1426795**

Officers responded to a **disturbance** call at the **Icon** regarding an intoxicated male who was causing problems. The male left as soon as officers arrived. No further information available.

**Saturday, February 19, 2011: 0225 hours**

**100 Block N 4<sup>th</sup> St – DUI - #11C04519**

Officers arrested a 22 year old male for **DUI (BAC = .128)** after a routine traffic stop (driving the wrong way down 4<sup>th</sup> St). The male admitted to drinking a couple of beers at the **Hogfish Bar** earlier in the evening.

**Sunday, February 20, 2011: 0122 hours**

**N 4<sup>th</sup> St & E Sherman Ave – Fight - #CD1427023**

Officers responded to a **fight** call reference two males fighting in the Diamond Lot near the **Iron Horse**.

**Sunday, February 20, 2011: 0214 hours**

**317 E Sherman Ave – Threatening - #CD1427031**

Officers responded to a **threatening** call reference an extremely intoxicated female in front of the **Icon**.

**Wednesday, February 23, 2011: 0215 hours**

**407 E Sherman Ave – Fight - #CD1427692**

Officers responded to a **fight** call reference several people fighting with a bartender in the parking lot of the **Iron Horse**. No further information available.
