### INTRODUCTION

This report was compiled on April 29, 2011 at the request of Captain Childers.

The types of information used to create this report include calls for service, crime reports and field interviews extracted from our Summit database.

Database records were reviewed and compiled based upon both how the record is related to a specific bar or bar activity in general in the downtown Coeur d'Alene area. The following is a table of the establishments and addresses associated with them.

Notably, it is not always possible to obtain information about where a suspect may have been drinking (e.g. too inebriated) or if a particular crime is directly related to a specific establishment. In that context, the purpose of this report is to provide a general overview of downtown activities in an effort to increase communication between bar establishments and local law enforcement with the final goal of improving public safety.

Information on BAC (Blood Alcohol Content) as referenced in this report:

State of Idaho BAC DUI Laws:

- All drivers with a BAC .08 or higher (enhanced if BAC .20 or more)
- Under 21 years of age with a BAC of .02 or higher
- Commercial Drivers with a BAC of .04 or more

#### Friday, April 22, 2011: 2124 hours

#### 317 E Sherman Ave – Disturbance - #CD1443348

Officers responded to a **disturbance** call at the **lcon** regarding a verbal argument between two friends. The fight was not physical and no action was taken.

#### Saturday, April 23, 2011: 0120 hours

#### 300 Block E Sherman Ave – Disorderly - #CD1443393

Officers responded to a **disorderly** call involving an intoxicated male yelling at another male. Officers intervened before the fight became physical.

#### Saturday, April 23, 2011: 0124 hours

#### 317 E Sherman Ave – Disturbance - #CD1443394

Officers responded to a **disturbance** call at the **lcon** involving an intoxicated male who was found facedown. According to the call, the male had been drinking at the **Baja** and the "**Beer.**" The male was put in a cab and sent home to his girlfriend (who was waiting for him).

#### Saturday, April 23, 2011: 0137 hours

#### 500 Block E Lakeside Ave – DUI - #11C10760

Officers arrested a 25 year old male for **DUI (BAC = .148)** after observing the intoxicated male get into and start up his vehicle. The male admitted to drinking and told officers he only started the car to get warmed up. The suspect told the officers he had been drinking beer and rum earlier in the evening; however, it is not apparent if he was drinking downtown and beer was found in the vehicle.

#### Saturday, April 23, 2011: 0150 hours

#### N 2<sup>nd</sup> St & E Lakeside Ave – Alcohol Offense - #11C10762

Officers cited two 21 year old males for **open container**. The two males were in the vehicle involved with the previously mentioned **DUI (#11C10760)** and after their buddy had been arrested, they were walking home with their beer. The males admitted to drinking the beer as they walked.

#### Saturday, April 23, 2011: 0157 hours

#### 317 E Sherman Ave – Disorderly- #CD1443400

Officers responded to a **disorderly** call at the **lcon** involving a high intoxicated female who was in and out of consciousness. Apparently the female was found by the bar security. Initially medical was called to check the girl out and officers were anticipating a medical protective custody hold; however, a friend picked her up.

#### Saturday, April 23, 2011: 0203 hours

#### 317 E Sherman Ave – Disturbance - #CD1443401

Officers responded to a **disturbance** call involving two females who had been arguing in the **lcon**. Both females claimed injuries from the fight. Both females refused to pursue charges against the other. No further action was taken.

#### Sunday, April 24, 2011: 0217 hours

#### N 4<sup>th</sup> St & E Sherman Ave – Fight - #CD1443659

Officers responded to a **fight** call involving two males hitting another male in the stomach. No further information available.
