INTRODUCTION

This report was compiled on April 20, 2011 at the request of Captain Childers.

The types of information used to create this report include calls for service, crime reports and field interviews extracted from our Summit database.

Database records were reviewed and compiled based upon both how the record is related to a specific bar or bar activity in general in the downtown Coeur d'Alene area. The following is a table of the establishments and addresses associated with them.

Notably, it is not always possible to obtain information about where a suspect may have been drinking (e.g. too inebriated) or if a particular crime is directly related to a specific establishment. In that context, the **purpose of this report is to provide a general overview of downtown activities in an effort to increase communication between bar establishments and local law enforcement with the final goal of improving public safety.**

Information on BAC (Blood Alcohol Content) as referenced in this report:

State of Idaho BAC DUI Laws:

- **All drivers** with a **BAC .08** or higher (**enhanced** if **BAC .20** or more)
- **Under 21 years of age** with a **BAC of .02** or higher
- **Commercial Drivers** with a **BAC of .04** or more

Saturday, April 2, 2011: 2348 hours

318 E Sherman Ave – Unwanted Person - #CD1437978

Officers responded to an **unwanted person** call at the **Icon** regarding a male who had been kicked out of the **Icon** and was now trying to kick in the back door. Apparently the male thought the bar was his house.

Saturday, April 2, 2011: 2354 hours

100 Block N 4th St – DUI - #11C08720

Officers arrested a 21 year old male for **DUI (BAC = .135)** after observing him driving the wrong way on both N 3rd St and N 4th St. The male admitted to drinking a couple of beers earlier in the evening, starting at 1600 hours.

Sunday, April 3, 2011: 0147 hours

315 E Sherman Ave – Disorderly - #CD1437994

Officers responded to a **disorderly** call at the **Icon** regarding a highly intoxicated male who had been kicked out of the **Icon** and was now yelling at security.

Sunday, April 3, 2011: 0155 hours

317 E Sherman Ave – Citizen Dispute - #CD1437996

Officers responded to a **Citizen Dispute** call at the **Icon**. No further information available.

Sunday, April 3, 2011: 0350 hours

600 Block E Sherman Ave – Domestic Battery - #11C08737

Officers responded to a **Domestic Battery** call at a motel in the 600 Block of Sherman involving a male and female. The Washington couple had rented a room to celebrate their anniversary in downtown Coeur d'Alene. It appears the two were drinking at the **Icon** when the husband became aggressive (his wife was talking to another male) and the wife walked back to the motel. Once the male returned to the motel, he became abusive to his wife and trashed the room knocking over the microwave, cracking the toilet and other damage. The male (34 years) was arrested for Domestic Battery.

Friday, April 8, 2011: 0010 hours

317 E Sherman Ave – Fight - #CD1439596

Officers responded to a **Fight** call at the **Icon** involving two females. The bartender was also injured, but did not want to press charges.

Saturday, April 9, 2011: 0044 hours

406 N 4th St – Battery - #CD1439601

Officers responded to a **Battery** call at **Mic's** involving a male who had punched a male bouncer in the face. The victim did want to press charges stating the suspect was someone he had been making out with before he was hit.

Saturday, April 9, 2011: 0054 hours

N 2nd St & E Lakeside Ave – Disorderly - #CD1439603

Officers responded to a **Disorderly** call reference an intoxicated male who had stepped out in front of the Reporting Party's vehicle. The suspect was gone on arrival.

Saturday, April 9, 2011: 0146 hours

N 3rd St & E Sherman Ave – Drugs - #11C09342

Officers arrested a Washington male (34 years) for **Drugs** after smelling marijuana and noticing the male smoking dope while standing with a group of 5-6 people on 3rd St.

E Sherman & N 12th St – DUI - #11C09343

Officers arrested a 44 year old male from Montana for **DUI** after noticing him driving down Sherman without his vehicle headlights on. The male admitted to drinking a few beers at the **Blue Moon** that evening.

N 2nd St & E Wallace Ave – DUI - #11C09344

Officers arrested 25 year old female for **DUI (BAC = .172)** after observing her driving down 2nd St without her vehicle headlights on. The female told officers that she and her male passenger had been drinking downtown, and she was giving him a ride home; however, there was an active civil protection order between the female and her boyfriend, and both were also cited for **Violation of a Civil Protection Order**.

Wednesday, April 13, 2011: 0342 hours

400 Block E Lakeside – DUI - #11C09746

Officers arrested a 50 year old female for **DUI (BAC = .229)** after officers noticed her slumped over her and passed out in her running vehicle. Officers attempted to wake the woman and when she attempted to roll down her vehicle window, she turned on her windshield wipers instead and revved her vehicle engine several times. Finally the woman was able to roll down her window but could not communicate coherently with the officers. It took her several tries to find her driver's license (kept giving officers her cell phone and bottle of lens cleaner). She did admit to consuming a beer that evening.

300 Block E Sherman Ave – Alcohol - #11C10091

Officers observed and cited two males (23 & 24 years) for **Open Container** after observing the males walking down Sherman Ave with beers in their hand. The males admitted to leaving the **Icon** with the beers.

407 E Sherman Ave – Unwanted Person - #CD1441583

Officers responded to an **Unwanted Person** call at the **Iron Horse**. No further information available.

Officers responded to a **Fight** call at the **Iron Horse** involving several people fighting on the corner of 3rd & Sherman.

Officers responded to a call of an intoxicated male dragging an intoxicated, undressed, and vomiting female in front of **Tito Macaroni's**. No further information available.

Officers responded to a **Fight** call at the **Icon** involving 4 – 5 males where one male was talking about getting a gun and using it on a woman. No further information available.

Officers responded to a **fight** call in front of the **Torch** involving an intoxicated male and bar security.
