INTRODUCTION

This report was compiled on April 4, 2011 at the request of Captain Childers.

The types of information used to create this report include calls for service, crime reports and field interviews extracted from our Summit database.

Database records were reviewed and compiled based upon both how the record is related to a specific bar or bar activity in general in the downtown Coeur d'Alene area. The following is a table of the establishments and addresses associated with them.

Notably, it is not always possible to obtain information about where a suspect may have been drinking (e.g. too inebriated) or if a particular crime is directly related to a specific establishment. In that context, the purpose of this report is to provide a general overview of downtown activities in an effort to increase communication between bar establishments and local law enforcement with the final goal of improving public safety.

Information on BAC (Blood Alcohol Content) as referenced in this report:

- All drivers with a BAC .08 or higher (enhanced if BAC .20 or more)
- Under 21 years of age with a BAC of .02 or higher
- Commercial Drivers with a BAC of .04 or more

Friday, March 4, 2011: 0020 hours

401 E Sherman Ave – Unwanted Person - #CD1430223

Officers responded to an **unwanted person** call at the **Moose Lounge** regarding an intoxicated male refusing to leave. Apparently the male had already been kicked out of the **Beacon** as well.

Friday, March 4, 2011: 0040 hours

N 4th St & E Birch Ave – DUI - #11C05778

Officers arrested a 27 year old female for **DUI (BAC = .265)** after a routine traffic stop (swerving in roadway and almost hit patrol car). The female indicated she had a couple glasses of wine at the **Eagles** earlier in the evening.

Saturday, March 5, 2011: 2258 hours

S 2nd St & E Front Ave – DUI - #11C05940

Officers responded to a call of a possible DUI and vehicle stuck in a snow berm in front of the **CDA Resort.** Notably, the vehicle was primarily on the sidewalk. Apparently the driver thought the snow berm was a roadway divider and proceeded to drive upon the sidewalk. When he realized he wasn't driving on the roadway, he attempted to cross "over" the berm and became stuck. The driver, a 24 year old male, was arrested for **DUI (BAC = .125).** He told officers he had a few drinks at the **Baja Bargarita** earlier in the evening.

Sunday, March 6, 2011: 0022 hours

407 E Sherman Ave – Battery - #11C05950

Officers responded to a **fight** at the **Iron Horse** involving a heavily intoxicated male, bouncers and bar patrons. Apparently, the male was asked to leave the bar and on his way out attempted to take a jacket that did not belong to him and swung at and punched bouncers several times. The male was also belligerent with officers claiming they beat him up, telling them how he hated the police and that they all were "piles of shit." The 33 year old male was arrested for **assault** and **battery** on the bouncers.

N 4th St & E Lakeside Ave – Fight - #CD1430700

Officers responded to a **fight** at **Mik's** (formally know as **9 Below** and before that **Mik n Macs**) involving two females. No further information available.

Sunday, March 6, 2011: 0136 hours

300 Block E Sherman Ave – Alcohol Offense - #11C05956

Officers contacted and warned a 21 year old male who was quite intoxicated and had been observed walking in the street and in front of a patrol car.

Sunday, March 6, 2011: 0149 hours

216 E Coeur d'Alene Ave – Disturbance - #CD1430708

While responding to a traffic stop in the parking lot, officers observed a **disturbance** in front of the **Rendezvous** involving several bouncers.

Sunday, March 6, 2011: 0158 hours

N 3rd St & E Sherman Ave – Disorderly - #CD1430710

Officers responded to a **disorderly** call involving a male who said his friend punched him in the face after getting kicked out of the **lcon**. The man didn't want to pursue charges as it was his friend.

317 E Sherman Ave – Disturbance - #CD1430716

Officers responded to a **disturbance** call involving an intoxicated cowboy who tried to get into the driver's side of a limo. The owner caught him and removed him, but did not want to press charges.

Northwest Blvd & N Lakewood Dr - DUI - #11C05963

Officers arrested a 30 year old for **DUI (BAC = .112)** after a routine traffic stop. The male told officers he has consumed four beers that evening at the **Icon** and **Iron Horse**.

Sunday, March 6, 2011: 0239 hours

200 Block E Lakeside Ave – DUI - #11C05966

Officers arrested a 23 year old for **DUI (BAC = .187)** after a routine traffic stop (driving the wrong way down 4^{th} St). At first the male indicated he had consumed a few beers at "Taps," but then remembered Taps is on Schweitzer Mountain and stated he had the beers at the **Icon**.

Sunday, March 6, 2011: 0222 hours

300 Block E Sherman Ave – Fight - #11C05968

Officers responded to a **fight** call (one male had pushed the other into a glass door) involving two males. They continued to argue after officers arrived and were warned.

Monday, March 7, 2011: 1203 hours

317 E Sherman Ave – Theft - #11C06056

Officers responded to a **theft** call regarding a stolen cell phone. According to the victim, the cell phone was stolen out of her coat pocket on Friday while at the **Icon**.

Wednesday, March 9, 2011: 2225 hours

N 4th St & E Boise Ave – DUI - #11C06313

Officers arrested a 45 year old male for **DUI** (**BAC** = .145) after a routine traffic stop (speeding). The male initially told officers he was speeding because he was mad about something that had happened in the bar, and he had nothing to drink that evening.

317 E Sherman Ave – Theft - #11C06056

Officers responded to a **disorderly** call regarding an intoxicated male stumbling at 4th & Sherman. No further information available.

200 Block E Sherman Ave – Vandalism - #11C06572

Officers responded to a **vandalism** call regarding damage to two windows on Sherman Ave.

Saturday, March 12, 2011: 2330 hours

200 Block of Sherman – Vandalism - #11C06544

Officers cited a 22 year old male for **Malicious Injury to Property** after tracking him down at the hospital. Apparently the male was very intoxicated, busted a window out of a business, and cut himself up pretty good. The male admitted to being very intoxicated and although he did not remember damaging the window, he admitted he was probably responsible due to his injuries. He told officers he had been celebrating a friend's birthday that evening.

401 E Sherman Ave – Fight - #11C06634

Officers responded to a **fight** call in front of the **Moose Lounge** involving several females. It is unclear exactly how the fight started. One female indicated it involved insulting comments over clothing. The other female stated she saw a mother and daughter arguing and went over to check it out. One of the females —the one officers saw push the other female—was cited for Fighting in Public.

300 Block E Sherman Ave – Welfare Check - #CD1432576

Officers responded to a **welfare check** call regarding a highly intoxicated male in the dirt parking lot behind a business. No further information available.

Wednesday, March 16, 2011: 0248 hours

N Government Way & E Miller Ave – DUI - #11C06900

Officers arrested a 24 year old male for **DUI (BAC = .113)** after a routine stop. The male had a few beers earlier at the **Iron Horse.** Two passengers in the vehicle were cited for **open container** (beer).

N 3rd St & E Roosevelt Ave – DUI - #11C06996 & #11C06997

Officers arrested a 21 year old male and a 20 year old male for **DUI** after responding to a call of two vehicles driving the wrong way on 3rd St. Although one of the offenders openly pointed out his firearm to the officer, it became an issue when the male picked up the gun causing officers to pin him to his seat until the firearm could be secured. The offenders had been drinking at the **Rendezvous** earlier in the evening.

Officers arrested a 35 year old male for **DUI (BAC = .138)** after a routine traffic stop. The offender advised he had a few beers at the **Eagles** earlier in the evening.

N 6th St & E Sherman Ave – DUI - #11C07108

Officers arrested a 45 year old female or **DUI (BAC = .253)** after a routine traffic stop. She told officers she had drank three beers earlier in the evening.

Officers responded to a call of a female who had been hit in the face by another female. No further information available.

800 Block E Sherman Ave – DUI - #11C07113

Officers arrested a 42 year old male or **DUI** after a routine traffic stop. The report mentions **Crickets.**

N 4th St & E Birch Ave – DUI - #11C07118

Officers arrested a 51 year old female or **DUI (BAC = .195)** after a routine traffic stop. The report mentions **Kelly's Irish Pub.**

400 Block N 3rd St – DUI - #11C07119

Officers arrested a 37 year old male for **DUI (BAC = .092)** after a routine traffic stop. The male admitted to drinking several beers at the **Iron Horse** that evening.

216 E Coeur d'Alene Ave – DUI - #11C07121

Officers arrested a 24 year old male for **DUI (BAC = .160)** after finding the offender passed out over the steering wheel of his parked, running vehicle. The male told officers he had been drinking at both the **Rendezvous** and **Icon** that evening.

325 E Sherman Ave – Unwanted Person - #CD1433917

Officers responded to a call regarding a **fight** at the **Beacon** that may have started at the **Icon** involving intoxicated people, male and female. Medical was called for an unconscious male. No further information available.

N 1st St & E Sherman Ave – DUI - #11C07124

Officers arrested a 20 year old female or **DUI (BAC = .197)** after a routine traffic stop (parked facing wrong way on S 3^{rd} St). The female told officers she had consumed a few beers at the **Moose Lodge.**

N 4th St & E Sherman Ave – Threatening - #CD1433923

Officers responded to a call regarding three females in two vehicles threatening to bring back their male friends and kill the reporting party (also male). No further information available.

Officers responded to a female outside the **Icon** attempting to flag down an officer. The female was intoxicated and had been seen fighting by bouncers and asked to leave the **Icon**. At first she claimed she was missing her wallet and \$850 but when her wallet was found said nothing about missing money.

Officers responded to a very large **fight** call outside of the **Pita Pit.** No further information available.

Saturday, March 19, 2011: 0210 hours

317 E Sherman Ave – Unconscious - #CD1434233

Officers responded to a call regarding an **unconscious** male outside of the **Beacon**. According to the call, the 24 year old male was in the roadway and people had moved him to the sidewalk. The male was conscious when officers arrived, but very intoxicated.

Saturday, March 19, 2011: 0212 hours

500 Block E Wallace Ave – Unlawful Entry - #11C07269

Officers responded to a call from a female regarding a stranger in her home. It appears the female was asleep but awakened by a noise and her dog barking. When she found the male standing in her apartment, she began yelling at him to get out. The male was very intoxicated and finally left the apartment. Officers initially could not find the male until the suspect circled back to the apartment and the female pointed him out. The male was too intoxicated to answer any questions and officers had to repeatedly ask him for his identification (he kept handing them his cell phone). The suspect's alcohol **BAC was .268.** The 24 year old male suspect was arrested for **unlawful entry.**

317 E Sherman Ave – Theft - #CD1434235

Officers responded to a call regarding a **theft.** A female who had been thrown out of the **lcon** reported cash and other items were missing from her purse. No further information available.

Saturday, March 19, 2011: 0232 hours

407 N 2nd St – Disturbance - #CD1434239

Officers responded to a call regarding a **verbal argument** between six males in the alley outside the **Lakers Bar.** No further information available.

Sunday, March 20, 2011: 0155 hours

N 2nd St & E Lakeside Ave – Battery - #11C07370

Officers responded to a call regarding a **physical fight** between 20 to 30 individuals. The main suspect was reportedly a male, without a shirt and tattoos on his back. Upon arrival officers located the suspect, a 23 year old male, who was arrested for **battery**. According to the suspect, he was drinking with friends at the **Baja Bargarita** with his girlfriend and friend and when they left they were attacked by a group of people. The group of people (many of whom were very intoxicated) had differing stories, including a female with a knot on her head who stated the suspect and his girlfriend attacked her.

Officers responded to a call regarding an **unwanted person** (intoxicated male) in the back alley behind the **Iron Horse** who was refusing to leave. No further information available.

317 E Sherman Ave – Battery - #CD1435821

Officers responded to a call regarding a **battery** at the **lcon** involving a female who had been thrown out of the bar and now had bruises and torn cartilage due to the incident (cold report – occurred previously).

Officers responded to a **disorderly** call at the **Beacon**. No further information available.

Officers responded to a **disorderly** call at the **Beacon** regarding a male who had urinated on the floor in the **lcon's** kitchen area and left on foot. The officers tracked the suspect down and because he returned and cleaned up his mess, they issued him a warning.

Officers responded to a **disorderly** call at the **Beacon** involving a verbal argument between a male and female. No further information available.

Officers responded to a **disorderly** call at the **Rendezvous** (formally the **Torch)** involving an intoxicated DJ / Dancer passed out on a bench in front of the bar. No further information available.

Officers responded to a **disorderly** call at **Mik's (formally 9 Below, Mik N Macs)** involving a male who was jumping on vehicles. No further information available.

Officers were flagged down and responded to a **welfare check** call at the **lcon** involving a female passed out in a vehicle. Apparently her friends were letting her sleep while they ate at the Pita Pit. No further information available.

407 N 2nd St – Battery - #11C08047

Officers responded to a **fight** call near the **Lakers Inn** where reportedly several people were kicking a male on the ground. Officers located the suspects at KMC; however did not locate the suspects at that time. According to the victims, the males jumped them after they left the **Rendezvous** (formally the **Torch**).

Officers responded to a **disorderly** call at the **Moose Market** involving a verbal argument between a male and several others. The male left on foot and kicked a garbage can and tree. No further information available.

N 5th St & E Sherman Ave – Fight - #11C08058

Officers observed a **fight** between two males who were pushing each other. The two were friends and one male was trying to stop the other from fighting with a group of males. Apparently the group had followed the two males from the **Beacon** and were trying to start a fight.

407 E Sherman Ave - Fight - #11C08061

Officers responded to a **fight** call at the **Iron Horse** involving a verbal argument between two males. The fight had started earlier in the evening at the **Icon** and after close, they ran into each other again. Multiple people were involved in the altercation. The suspect left the scene prior to law enforcement arrival and although the victim did not want to press charges, he went to the hospital to treat his broken jaw and then while leaving the emergency room, he saw the suspect and contacted the police. All parties were warned for fighting in public.

Officers responded to a **battery** call reference a drunk driver who had hit someone in the face. No further information available.
