INTRODUCTION

This report was compiled on May 6, 2011 at the request of Captain Childers.

The types of information used to create this report include calls for service, crime reports and field interviews extracted from our Summit database.

Database records were reviewed and compiled based upon both how the record is related to a specific bar or bar activity in general in the downtown Coeur d'Alene area. The following is a table of the establishments and addresses associated with them.

Notably, it is not always possible to obtain information about where a suspect may have been drinking (e.g. too inebriated) or if a particular crime is directly related to a specific establishment. In that context, the purpose of this report is to provide a general overview of downtown activities in an effort to increase communication between bar establishments and local law enforcement with the final goal of improving public safety.

Friday, April 29, 2011: 0226 hours

216 E Coeur d'Alene Ave - Theft - #CD1445034

Officers responded to a **theft** call at the **Rendezvous** regarding the theft of a customer's bag. The victim had very little suspect information and a video of male taking bag.

Friday, April 29, 2011: 2346 hours

317 E Sherman Ave – Disorderly - #CD1445354

Officers responded to a **disorderly** call at the **lcon**. No further information available.

Saturday, April 30, 2011: 0048 hours

317 E Sherman Ave – Disturbance - #CD1445365

Officers responded to a **disturbance** call at the **lcon** regarding a male detained and tazed by bouncers. Call information indicates the male was physically fighting.

Saturday, April 30, 2011: 0122 hours

317 E Sherman Ave – Trespassing - #11C11503

Officers responded to a **disturbance** call in front of the **Icon** (see previous call #CD1445365). Upon arrival, officers found a group of approximately 20 people watching a fight on the sidewalk and bouncers restraining two males. One of the suspects, a 23 year old male, was restrained because he continued to fight while being escorted away from the bar. The bouncer did not want to press battery charges against the male; however, the male was trespassed from the bar for one year. Approximately 35 minutes later, a bouncer from the **Icon** ran to a patrol car driving down Sherman to report the male had returned to the **Icon** and was now at the entrance trying to start another fight. Officers attempted to speak with the male, told him several times to leave the area, and when the male would not comply, he was arrested for **trespassing**. The male was not compliant with officers after his arrest and would not get into the patrol vehicle until the officer kneed him in the thigh and tazed him. Once the suspect was in the vehicle, he lay back on the seat and kicked an officer in the shoulder / chest area until another officer grabbed the suspect from the other side of the car and pulled him into the vehicle. The suspect was also charged with **battery on a police officer**.

E Sherman Ave & N 5th St - Disorderly - #CD1445459

Officers responded to a **disorderly** call involving a male walking west on Sherman yelling profanities at people. Intoxication or drug use was suspected.

Sunday, May 1, 2011: 0033 hours

317 E Sherman Ave - Battery - #11C11598

Officers responded to a **Battery** call at the **Icon** involving a 28 year old male suspect who had grabbed his girlfriend by the hair and pulled her down. The victim, a 24 year old female, was highly intoxicated. Officers were unable to locate the suspect.
