INTRODUCTION

This report was compiled on May 27, 2011 at the request of Captain Childers.

The types of information used to create this report include calls for service, crime reports and field interviews extracted from our Summit database.

Database records were reviewed and compiled based upon both how the record is related to a specific bar or bar activity in general in the downtown Coeur d'Alene area. The following is a table of the establishments and addresses associated with them.

Notably, it is not always possible to obtain information about where a suspect may have been drinking (e.g. too inebriated) or if a particular crime is directly related to a specific establishment. In that context, the **purpose of this report is to provide a general overview of downtown activities in an effort to increase communication between bar establishments and local law enforcement with the final goal of improving public safety.**

Information on BAC (Blood Alcohol Content) as referenced in this report:

State of Idaho BAC DUI Laws:

- **All drivers** with a **BAC .08** or higher (enhanced if **BAC .20** or more)
- **Under 21 years of age** with a **BAC of .02** or higher
- **Commercial Drivers** with a **BAC of .04** or more

Friday, May 20, 2011: 2115 hours

N 3rd & E Sherman Ave – Alcohol Offense - #CD1451362

Officers warned a male for **open container**. The male was coming from the **Rendezvous (aka: The Torch)**.

Friday, May 20, 2011: 2348 hours

407 E Sherman Ave – Fight - #CD1451398

Officers responded a **fight** call near the **Iron Horse** involving two males fighting in the street.

Saturday, May 21, 2011: 0102 hours

317 E Sherman Ave – Disorderly - #CD1451413

Officers responded to a **disorderly** call at the **Icon** involving a highly intoxicated female and male. The female was barely able to stand. A cab was found and they were sent on their way.

Saturday, May 21, 2011: 0122 hours

300 Block E Sherman Ave – Disorderly - #CD1451417

Officers warned a 30 year old male for **urinating** in an alley behind the **Wine Cellar**.

Saturday, May 21, 2011: 0134 hours

100 Block N 4th St – Disorderly - #CD1451418

Officers responded to a **disorderly** call involving a highly intoxicated male passed out at the eatery table. Apparently his friend had abandoned him. The friend was found and they were sent on their way in a cab.

Saturday, May 21, 2011: 0240 hours

300 Block E Sherman Ave – Disorderly - #CD1451431

Officers warned a male who was about to **urinate**. Initially the male told officers he was “checking out the park,” but when the officer pointed out the male’s zipper was down, he admitted his intention.

Saturday, May 21, 2011: 0251 hours

100 Block S 4th St – Disorderly - #CD1451436

Officers warned an **intoxicated** male who was standing in the middle of the crosswalk at 4th St & Sherman. The officers had to activate their siren to get the male’s attention and get him to move.

Sunday, May 22, 2011: 0010 hours

317 E Sherman Ave – Littering - #11C13987

Officers cited a 21 year old Washington woman for **littering** in front of the **Icon**. Apparently the woman flicked her lit cigarette to the ground, walked away, and when the officer spoke with her about it she had a bad attitude.

Sunday, May 22, 2011: 0024 hours

N 3rd St & E Sherman Ave – Disorderly - #11C13988

Officers responded to a **disorderly** call regarding a 50 year old, highly intoxicated male who was being carried by another male to the bench at 3rd & Sherman. The male was too intoxicated to walk. The males told the officers they were on the Spokane Party bus and would wait for it to pick them up. These males resulted in multiple contacts throughout the night.

Sunday, May 22, 2011: 0028 hours

216 E Coeur d'Alene Ave – Alcohol Offense - #CD11451729

Officers warned a male about an open container of beer. The male came from the **Baja**. Officers were too busy to deal with him, had him dump out his beer and go on his way.

Sunday, May 22, 2011: 0035 hours

411 E Sherman Ave – Disorderly - #11C13990

Officers arrested a 28 year old male for **urinating in public**. The male was also on Felony Probation and out after curfew.

Sunday, May 22, 2011: 0045 hours

N 3rd St & E Sherman Ave – Citizen Assist - #CD1451732

Officers responded to a **citizen assist** call and helped the male get into a cab. The male had been drinking at assorted downtown bars all evening and had dislocated his shoulder.

Sunday, May 22, 2011: 0055 hours

100 S 4th St – Parking Problem - #11C13992

Officers cited four vehicles for parking in the taxi pickup area. This appears to be a problem over the past few weeks.

Sunday, May 22, 2011: 0130 hours

300 Block E Sherman Ave – Fight - #CD1451725

Officers responded to a **fight** call at the **Icon** involving 3 or 4 males. Bar security escorted the males out the back door of the **Icon** and attempted to break up the fight.

Sunday, May 22, 2011: 0125 hours

300 Block E Sherman Ave – Disorderly - #CD1451739

Officers responded to a **disorderly** call reference a male in the alley who was too intoxicated to walk. His friend was trying to carry him; however, the intoxicated male fell down multiple times.

Sunday, May 22, 2011: 0143 hours

N 4th St & E Harrison Ave – DUI - #11C13999

Officers arrested a 63 year old male for **DUI** after a routine traffic stop (driving without his headlights on). When told why he was pulled over, the male asked officers, "Is that a crime?" The male told officers he had been drinking beer at **Lakers** that evening.

Sunday, May 22, 2011: 0200 hours

N 4th & E Sherman Ave – Disorderly - #CD1451746

Officers responded to a **disorderly** call involving an intoxicated male trying to start fights. The male was turned over to his friend who took him home.

Sunday, May 22, 2011: 0218 hours

300 Block E Front – Disorderly - #11C14003

Officers cited a 24 year old male for **urinating in public**. The male was very intoxicated and told officers he did it to avoid going in his pants.

Sunday, May 22, 2011: 0223 hours

100 Block of N 5th St – Disorderly - #11C14004

Officers arrested a 23 year old male for **fighting in a public place**. Officers had encountered the male earlier in the evening fighting with other males and had to be warned several times to control his violent behavior or be tazed.

Sunday, May 22, 2011: 0241 hours

400 E Sherman Ave – Disorderly - #11C14006

Officers cited a 29 year old Washington male for **urinating in public**.

Tuesday, May 24, 2011: 0200 hours

216 E Sherman Ave – DUI - #11C14199

Officers arrested a 45 year old Washington male for **Excessive DUI (BAC = .268)** after receiving a call of an intoxicated male who had fell three times in the **Rendezvous (aka The Torch)** parking lot and had driven off in his vehicle. The male was located on Northwest Blvd, pulled over and arrested.
