#### INTRODUCTION

This report was compiled on June 9, 2011 at the request of Captain Childers.

The types of information used to create this report include calls for service, crime reports and field interviews extracted from our Summit database.

Database records were reviewed and compiled based upon both how the record is related to a specific bar or bar activity in general in the downtown Coeur d'Alene area. The following is a table of the establishments and addresses associated with them.

Notably, it is not always possible to obtain information about where a suspect may have been drinking (e.g. too inebriated) or if a particular crime is directly related to a specific establishment. In that context, the purpose of this report is to provide a general overview of downtown activities in an effort to increase communication between bar establishments and local law enforcement with the final goal of improving public safety.

Information on BAC (Blood Alcohol Content) as referenced in this report:

#### State of Idaho BAC DUI Laws:

- All drivers with a BAC .08 or higher (enhanced if BAC .20 or more)
- Under 21 years of age with a BAC of .02 or higher
- Commercial Drivers with a BAC of .04 or more

#### Wednesday, June 1, 2011: 2330 hours

#### 407 E Sherman Ave - Disorderly - #CD1454994

Officers responded to a **disorderly** call at the **Iron Horse** involving a male who had been kicked out of the bar and was attempting to get people on the sidewalk to fight with him.

#### Thursday, June 2, 2011: 0015 hours

## 216 E Coeur d'Alene Ave – Disorderly - #11C15242

Officers cited a 22 year old male for **urinating in public.** The male had been drinking at the **Rendezvous** that evening.

#### Friday, June 3, 2011: 0045 hours

#### N 3<sup>rd</sup> St & E Coeur d'Alene Ave – DUI - #11C15366

Officers arrested a 50 year old male for **DUI (BAC = .114)** after a routine traffic stop (had pulled in front of another vehicle so close the vehicle had to brake hard to avoid a collision). The male admitted he had not seen the other vehicle. He told the officer he had consumed a couple of beers at the **Eagles** earlier in the evening.

#### 317 E Sherman Ave - Fight - #CD1455299

Officers responded to a **fight** involving several people outside of the **Beacon**. The fighting parties were gone on officer arrival.

## N 4<sup>th</sup> & E Sherman Ave – Suspicious - #CD145537

Officers responded to a call of a male flashing gang signs at people passing by while sitting at a table in front of the **Beacon**.

## E Lakeside Ave & N 4<sup>th</sup> Ave - DUI - #11C15366

Officers responded to a possible **DUI** call involving a very intoxicated female. According to the call, the female urinated on herself before getting into her vehicle and was headed east on Front. Officers were unable to locate her.

Officers responded to a call of a highly intoxicated male who was trying to walk down the stairs at the **Wine Cellar.** The male was warned.

Officers responded to an Alcohol call. No further information available.

#### 300 Block E Sherman Ave – Battery - #11C15489

Officers observed a physical altercation outside of the **Pita Pit** between two males. One of the male was bleeding, intoxicated, and could not identify the male who had hit him.

#### 200 Block E Sherman Ave – Battery - #11C15491

Officers were flagged down by a man running down Sherman saying, "They are fighting again." The males were the same as previously mentioned fighting in front of the **Pita Pit** and this time not only hit the previous victim but another male. The 40 year old male suspect was arrested on charges of **Battery**. According to the suspect, he had attempted to leave the area after the first altercation; however the victim kept following him, wanting to fight and argue, resulting in the suspect head-butting the victim.

Officers responded to another Fight call at N 3<sup>rd</sup> & Sherman. Further details are unknown.

Officers responded the **Rendezvous** regarding a man who had been trespassed from the bar in July of 2010 but now was at the bar once more. The male was warned.

Officers arrested a 22 year old male for **DUI (BAC = .201)** after receiving a call of a motorcycle seen falling over while driving on Northwest Blvd and locating the driver swerving up Ramsey Road.

Officers responded to a call of two males throwing trash cans around in the alley behind the **Wine Cellar.** The males were gone when police arrived.

Officers responded to a cold call of a **battery** where a male claims he was involved in a **fight** at the **lcon** Saturday night. The male wanted to report the battery, but did not want to press charges.

Officers responded to **battery** call where a male had punched another male (**Iron Horse** worker) in the nose. According to the report, the suspect had been partying most of the evening (21<sup>st</sup> birthday). Later on in the evening, the victim saw the suspect outside and congratulated him on this birthday. The suspect responded by punching the victim in the nose. The suspect then left in a vehicle and was not located by officers.
