INTRODUCTION

This report was compiled on August 19, 2011 at the request of Captain Childers.

The types of information used to create this report include calls for service, crime reports and field interviews extracted from our Summit database.

Database records were reviewed and compiled based upon both how the record is related to a specific bar or bar activity in general in the downtown Coeur d'Alene area. The following is a table of the establishments and addresses associated with them.

Officers responded to a **fight** call behind the **Icon** involving a male reportedly threatening to pull a gun. Upon arrival, officers contacted the suspect, a 24 year old Spokane male and his 21 year old sister. As the male was placed into handcuffs, he was verbally abusive to officers. Officers then attempted to speak with the female; however, she kept yelling at bouncers and trying to escalate the situation. The female was placed in handcuffs as well. Apparently the top floor of the **Icon** had been closed off that evening; however, the suspect kept going upstairs even though warned by bouncers. Eventually the bouncers attempted to guide him down the stairs, a scuffle ensued, and the girlfriend joined in the struggle hitting bouncers. During the struggle, the male told bouncers he was going to “slit their throats” and that he was part of an Italian Mafia. At one point during the struggles, bouncers picked up the female and put her outside where she began yelling and picked up a cast iron bench and attempted to break a window.

Officers arrested a 22 year old Washington male for **assault / battery** after responding to a call of a male being hit in the head by another male at **Splash**. According to the victim, a 32 year old male, he had been entering **Splash** when he was pushed then hit in the back of the head by the other male. Officers had to “bear hug” the suspect and take him to the ground. The suspect was intoxicated.

Monday, August 15, 2011: 0058 hours

200 Block E Sherman Ave – Battery - #11C24982

Officers arrested a 21 year old male for **assault / battery on a police officer and carrying a concealed weapon under the influence of alcohol / drugs**. Officers had first noticed the male outside of **Splash** where he was obviously upset and agitated – yelling at another male and towards a group of males. At one point he yelled “fuck the cops,” and his two male friends attempted to calm him down and the three began walking down Sherman Ave away from **Splash**; however, he broke away from his friends, attempted to walk back to the bar and aggressively approached one officer saying, “What does this motherfucker have to say.” Officers noticed the male grab something and could not tell if the male was grabbing something out of his pocket or had something in his hand. The male was taken to the ground. A crowd of people formed – some listening to officers and others not creating an unstable situation. When the male was taken into custody, officers found a folding knife in his pocket and charged him with additional charges of **carrying a concealed weapon under the influence of alcohol**.
