#### INTRODUCTION

This report was compiled on August 12, 2011 at the request of Captain Childers.

The types of information used to create this report include calls for service, crime reports and field interviews extracted from our Summit database.

Database records were reviewed and compiled based upon both how the record is related to a specific bar or bar activity in general in the downtown Coeur d'Alene area. The following is a table of the establishments and addresses associated with them.

Officers responded to a **domestic battery** call involving a Washington 24 year old male and 24 year old female arguing in the sidewalk. Both were intoxicated and unstable on their feet. Apparently the fight had started on the **lcon** bar when the male was dancing with female #1 and his girlfriend wanted him to stop and go home. The couple then began to argue aggressively--yelling at each other face-to-face. At some point the male slapped his girlfriend, left and found female #2 to dance with. His girlfriend went outside, where female #1 offered the male's girlfriend a ride home, and the two started walking down the sidewalk. At some point, the male exited the building and the fight between him and his girlfriend continued. After officer contact, the two were separated and sent to different locations for the evening.

Officers responded to a **domestic battery** call involving a 32 year old male and 33 year old female. Apparently the two had been drinking at the **Iron Horse** earlier in the evening, but at some point he wanted to go home (had to go to work in the morning) but she didn't want to leave. After some harassment by the female and her friends (called him a "fuddy duddy"), the two headed out to get a hamburger on the way home. At this time, the male remembered he left his debit card at the bar, and they would need to return to pick it up. This made the female angry. She began to drive erratically. He told her to stop. She stopped the vehicle, backhanded her 32 year old boyfriend in the face with her fist, slapped and kicked him. When she was done hitting him, she took off with the vehicle. Both were intoxicated. She was arrested the next day for **domestic battery**.

#### Friday, August 5, 2011: 0153 hours

#### 400 Block E Sherman Ave - Disorderly - #11C23707

Officers cited a 27 year old male for **urinating in public** after observing him do so in the alley way. The male was intoxicated and had been drinking at **Splash**.

#### Saturday, August 6, 2011: 0012 hours

#### 200 E Sherman Ave - Battery - #11C23860

Officers responded to a **battery** at **Splash** involving two males (ages 47 and 22) and a 53 year old female. Apparently the older male and female were a couple. The female was not feeling well and had put her head down on a table. The younger male, who was very intoxicated, walked by, rubbed her head and laughed. This made the older male angry (his girlfriend was bald because she was going through chemo), and he punched the younger male in the back of the head. Both males were arrested for **battery**. The younger male admitted to drinking at the **Moose Lounge** and the **Iron Horse** prior to his visit to **Splash**.

#### N 6<sup>th</sup> St & E Sherman Ave – Battery - #11C23877

Officers responded to a **shoplifter** call involving a 24 year old intoxicated male who had left either the **Icon** or **Iron Horse** and had reportedly attempted to steal something from one of the street fair tents. The male was apprehended by private security and at that time pushed the 24 year old security officer. The security officer handcuffed the male and called for back up (his 23 year old son and wife who were also working security.) At some point, the handcuffed male made lewd comments about the security guard's wife and the guard's son punched the male in the face. The shoplifter was cited for **battery** on the security guard. The security guard's son was cited for **battery** on the shoplifter.

#### 300 Block Sherman Ave - Malicious Injury to Property - #11C23881

Officers cited an intoxicated 21 year old male for **malicious injury to property** after he had passed out in a vendor's booth, fell and damaged property (shelving and candles).

# 115 S 2<sup>nd</sup> St - Battery - #11C23885

Officers arrested an intoxicated 21 year old male for battery at the Coeur d'Alene Resort.

Reportedly the male had been sleeping off his drunkenness on a couch, but when security attempted to wake him, he became combative and verbally abusive with both security and police officers. After a struggle, the male was detained, arrested and taken to jail.

He was found to be impaired and arrested for his 2<sup>nd</sup> **DUI**.
