INTRODUCTION

This report was compiled on September 8, 2011 at the request of Captain Childers.

The types of information used to create this report include calls for service, crime reports and field interviews extracted from our Summit database.

Database records were reviewed and compiled based upon both how the record is related to a specific bar or bar activity in general in the downtown Coeur d'Alene area. The following is a table of the establishments and addresses associated with them.

In that context, the **purpose of this report is to provide a general overview of downtown activities in an effort to increase communication between bar establishments and local law enforcement with the final goal of improving public safety.**

He was arrested for **Resisting / Obstructing** as well.

Officers arrested a 36 year California male for **Open Container** after observing the male sitting outside of the **Icon** with a can of beer in his pocket. The male was very intoxicated and had difficulty walking and following directions (instead of depositing the can in a trash can, he walked by the trash can and attempted to enter the **Icon**). When officers began to cite the male, he told them he was leaving Coeur d'Alene right away and had no intention of taking care of the citation. In addition, another officer came forward and indicated the male had been warned earlier about two **open containers of beer ("two fisted")**. The male was arrested.

Both the mother and daughter were 86'd from the **Iron Horse**.
