INTRODUCTION

This report was compiled on September 30, 2011 at the request of Captain Childers.

The types of information used to create this report include calls for service, crime reports and field interviews extracted from our Summit database.

Database records were reviewed and compiled based upon both how the record is related to a specific bar or bar activity in general in the downtown Coeur d'Alene area. The following is a table of the establishments and addresses associated with them.

Notably, it is not always possible to obtain information about where a suspect may have been drinking (e.g. too inebriated) or if a particular crime is directly related to a specific establishment. In that context, the **purpose of this report is to provide a general overview of downtown activities in an effort to increase communication between bar establishments and local law enforcement with the final goal of improving public safety.**

200 Block E Sherman Ave - #CD1488985 – Disorderly – Highly intoxicated female lying around the base of a tree in front of **Splash**. Female was barely able to stand or talk coherently. Vomit on the sidewalk. Bartender warned about over service. **Warned.**

317 E Sherman Ave - #CD1492609 – Fight – Physical fighting involving over ten people in front of the **Beacon**. **No Report.**

N 2nd St & E Sherman Ave - #CD1492900 – Fight – Eight subjects in the middle of the road fighting. **Warned.**

Sunday, September 18, 2011: 0217 hours

N 2nd St & E Sherman Ave - #CD1492903 – Fight – Fight involving approximately twenty people. **Warned.**

Wednesday, September 21, 2011: 2342 hours

216 E Sherman Ave - #CD1494074 – Fight – Fight in street in front of **Rendezvous** involving four to five males. **No Report.**

Thursday, September 22, 2011: 0033 hours

216 E Sherman Ave - #CD1494078 – Fight – Fight involving 10 people in front of **Rendezvous**.

Friday, September 23, 2011: 2309 hours

317 E Sherman Ave - #CD1494758 – Battery – Crying male claims he was battered by someone at the **Icon**. According to Icon employee, "victim" broke door inside of the bar and he was thrown out the back door. The male was located and paid for the door. **No Report.**

Saturday, September 26, 2011: 0019 hours

216 E Coeur d'Alene Ave - #CD1495327– Disorderly – Highly intoxicated female had walked into a male's apartment and locked herself in his bathroom. When she was asked to leave, she found an unlocked vehicle in the alley nearby. She was unable to give officers a correct address or say where she was drinking that evening. Her car was located in the 100 block of Coeur d'Alene Ave and her purse was found at the **Rendezvous**. The bartender did recognize the female and advised he had cut off several people that night. **Warned.**

200 E Sherman Ave - #CD1495089 – Falls – Female climbed onto the bar at **Splash** and fell off, cracking her head open. The female was unconscious, but breathing. **No report.**

Thursday, September 29, 2011: 0116 hours

N 2nd St & E Coeur d'Alene Ave - #CD1496211– Vehicle Theft – Very intoxicated male calling to report his vehicle had been stolen. **No Report.**

320 E Sherman Ave - #11C28716 – Vandalism

Officers responded to a **vandalism** call reference a vehicle that had been damaged during a fight. See **battery** incident **#11C28718**.

Saturday, September 17, 2011: 2259 hours

320 E Sherman Ave - #11C28716 – Disorderly

Officers cited a 23 year old male for **pedestrian intoxicated in the roadway** after observing a very intoxicated male stumbling across the intersection when the “do not walk” sign was flashing. The officer assisted the male out of the intersection. He admitted to drinking at the **Moose** that evening and his friends agreed to take care of him.

Saturday, September 17, 2011: 2330 hours

200 E Sherman Ave - #11C29717 – Petit Theft

A bartender from **Splash** reported someone had stolen his coat and keys while being stored behind the bar.

Sunday, September 25, 2011: 0119 hours

317 E Sherman Ave - #11C30394 – Alcohol Offense

Officers cited a 24 year old male for **open container** after observing the male standing outside the **Icon** holding a bottle of beer.

Fights / Batteries / Resisting

Thursday, September 8, 2011: 2232 hours

407 E Sherman Ave - #11C28445 – Battery

Officers responded to a **battery** call reference two 21 year old females fighting at the **Iron Horse**. Apparently this was payback for a **battery** that had occurred the prior week in another bar.

Saturday, September 10, 2011: 2150 hours

N 2nd St & E Lakeside Ave - #11C28686 – Battery

Officers responded to a **battery** call involving a 28 year old male who had punched his 28 year old wife in the mouth. The female was crying, did not want her husband to go to jail, and was uncooperative with officers. She finally told them that the couple had been at a wedding celebration at the **Eagles Lodge** that evening, and her husband wanted to leave, but she wanted to stay. As they left they began to argue, leading to the physical confrontation when he punched her in the mouth. She later revised the story saying she was pushed and fell hitting a planter with her mouth. Both were under the influence of alcohol.

Sunday, September 11, 2011: 0222 hours

320 E Sherman Ave - #11C28718 – Fight

Officers responded to a **fight** call near the **Pita Pit** reportedly involving bouncers from the **Icon** and male suspects. Upon arrival, the officer had to locate two of the males who were walking away; stop two other males from arguing; then with the assistance of the bouncers, break up a fight between the two males. The two males were intoxicated. Additional officers arrived and helped control the situation. The two males (22 & 25 years) were cited for **fighting in public**; however one male became belligerent and would not accept his citation. He was arrested.

Friday, September 16, 2011: 0025 hours

200 E Sherman Ave - #11C29349 – Battery

Officers responded to a **battery** call at **Splash** where a 25 year old male bouncer had been assaulted by a large, heavy set woman wearing only a bra. Apparently the bouncer had broken up a fight involving the suspect female and another female, and as he was escorting them out of the bar, the suspect turned and swiped her set of keys across his face. The females had left the scene and officers were unable to locate them.

Saturday, September 17, 2011: 0056 hours

216 E Coeur d'Alene Ave - #11C29488 – Battery

Officers responded to a **battery** call involving the **Rendezvous** where a 28 year old male claimed he was punched in the face by the bar's bouncers. The male did appear to have been hit hard in the face (right eye swollen shut, facial bruising and swelling). The male claimed he was in the bar drinking with two friends. He purchased a lap dance for himself and his friend, and after his dance went to the bar to get a drink. While at the bar, the male claims a bouncer grabbed and held him in place while another bouncer punched him four times in the face. The male stated the bouncer never asked him to leave or spoke to him before punching him. The male believes the bouncers may have mistaken him for someone else. The male was transported to KMC by ambulance.

Saturday, September 17, 2011: 0142 hours

N 4th St & E Sherman Ave - #11C29494 – Fight

Officers responded to a **fight** call in the street near the **Beacon** involving a large crowd and two males (19 and 21 years). Upon arrival, one of the males started walking away and ignored officers when they commanded him to stop. Both males were cited for **fighting in public**. One of the males

was only 19 years old and highly intoxicated. When asked about his age and drinking, he admitted to drinking a beer in the bar he was in front, stating, he had walked into the bar when there were no bouncers outside. He was also cited for **MIP alcohol**.

Saturday, September 24, 2011: 0005 hours

317 E Sherman Ave - #11C30287 – Battery

Officers responded to a **battery** call at the **Beacon** involving a 25 year old female, carrying a zebra striped purse that had spit on a bouncer's face and left walking northbound on 4th St. Officers contacted the female who admitted to trying to get into the **Beacon**, but she was denied entry because of her pink shirt. She was upset about this. After being denied entry, the female and her friend walked away, but returned to "flip off" the bouncers, yell at them and spit on the window. According to the victim, she didn't intend to spit on the bouncers, but some of her spit must have "deflected" from the window and hit him. She also admitted to later taking off her pink shirt, replacing it with a black one (because she didn't want people looking for the girl with the pink shirt and zebra purse). Apparently the whole incident began over a misunderstanding and mistaken identity where the bouncer had approached the suspect (thinking she was a friend of a friend) and jokingly made a comment about her pink shirt and told her she was 86'd from the bar, upsetting the already intoxicated female and setting this incident in motion...

Saturday, September 24, 2011: 2354 hours

216 E Coeur d'Alene Ave - #11C30385 – Battery

Officers responded to a **fight** call at the **Rendezvous** involving several males and females fighting in front of the bar and one male had been kicked in the face and was bleeding everywhere. Apparently one of the males had walked into the bar parking lot and came upon another male hitting a female and attempted to break up the fight resulting in the two males fighting (moving from the bar parking lot to the Coeur d'Alene Athletic Club parking lot). The assaulted female (who was intoxicated) told officers she had approached the suspect male, who was an acquaintance, and had asked him "What is going on in your life?" (Because she thought he was doing drugs again). At this, the suspect male became upset and pushed her down to the ground. Another female told officers she had contact with the suspect male earlier when he elbowed her, causing her to hit her head against the wall. When this female and her husband were leaving the bar, they witnessed the suspect male kicking the 1st female and another male who was trying to break up the fight. At this point, the suspect male noticed the second female, called her a name, doubled up his fist and hit her on the cheek and then ran away.

Thursday, September 29, 2011: 0138 hours

216 E Coeur d'Alene Ave - #11C30775 – Battery

Officers responded to a **fight** call in front of the **Rendezvous** involving three females (21, 25 & 25 years). As officers arrived, female #1 was being detained by bouncers and female #2 stated female #3 had punched her. Apparently females #1 & #2 (who are friends) had been removed from the bar because female #1 had "shouldered checked" female #3 while in the bar. A while later females #1 & 2 were allowed to stand just inside the bar doorway while waiting for a ride. While they were waiting, female #3 (victim of the shouldering) punched female #2 (not the one who had shouldered her) in the face. According to female #3, females #1 and #2 had been harassing her for the past couple of months because she broke up with her girlfriend, who is a friend of female #2 and when she saw them in the doorway she felt threatened. Female #3 was cited for **battery**.
