INTRODUCTION

This report was compiled on October 28, 2011 at the request of Captain Childers.

The types of information used to create this report include calls for service, crime reports and field interviews extracted from our Summit database.

Database records were reviewed and compiled based upon both how the record is related to a specific bar or bar activity in general in the downtown Coeur d'Alene area. The following is a table of the establishments and addresses associated with them.

Notably, it is not always possible to obtain information about where a suspect may have been drinking (e.g. too inebriated) or if a particular crime is directly related to a specific establishment. In that context, the **purpose of this report is to provide a general overview of downtown activities in an effort to increase communication between bar establishments and local law enforcement with the final goal of improving public safety.**

Disorderly / Citizen Disputes / Alcohol Related:

Saturday, October 1, 2011: 0024 hours

406 N 4th St - #CD1496931 – Disorderly – Unconscious 43 year old woman on the ground in front of **Mik's** – possible alcohol poisoning with people arguing about how to treat her. Medical contacted.

Saturday, October 1, 2011: 0103 hours

300 Block N 3rd St - #CD1496940 – Unconscious – Unconscious and unresponsive male. Medical contacted.

Saturday, October 1, 2011: 0103 hours

100 Block E Lakeside Ave - #CD1496942 – Welfare Check – Open 911 call with unknown male breathing oddly as if hurt. Unconscious male (20's) located in parking lot and transported to KMC.

216 E Coeur d'Alene Ave - #CD1496947 – Agency Assist – Local law enforcement and Probation & Parole bar checks at the **Rendezvous**.

Saturday, October 1, 2011: 0200 hours

322 E Sherman Ave - #CD1496953 – Unconscious – Female slumped over table – unable to wake her up. No report taken.

Saturday, October 1, 2011: 1837 hours

100 - 200 Block E Sherman Ave - #CD1497163, CD1497164, CD1497166, CD1497170, CD1497171 – Alcohol Offenses – Several people warned for having beer outside of an Oktoberfest tent. According to officers, there was not enough security on the back of the tent and people were walking around carrying steins of beer.

Sunday, October 2, 2011: 0029 hours

407 E Sherman Ave - #CD1497245 – Trespassing – Trespassing call at the **Iron Horse**. Bar did not want to press charges at that time.

Saturday, October 8, 2011: 0048 hours

N 8th St & E Sherman Ave - #CD1499165 – Unconscious – Male appears to be passed out by the entry to **Zips**. Medical called.

Saturday, October 8, 2011: 2154 hours

209 E Sherman Ave - #CD1499411 – Harassment – Intoxicated males were harassing female at the **Eagles**. Eagles handled problem.

Wednesday, October 12, 2011: 0148 hours

424 E Sherman Ave - #CD1499275 – Fall – Intoxicated 60 year old male fell and hit his head at **Crickets**. The male was unconscious but breathing and Medical was called.

Thursday, October 13, 2011: 0003 hours

407 E Sherman Ave - #CD1500589 – Unconscious – Intoxicated male face down in alley and unable to talk. Subject was found by **Iron Horse** employees. Subject refused medical and started walking down alley.

Saturday, October 15, 2011: 0156 hours

E Lakeside & N 4th St - #CD1501246 – DUI – Possible DUI sighted leaving area at **Icon** where suspect was intoxicated and stumbled to the ground when trying get into vehicle.

Saturday, October 15, 2011: 0249 hours

N 4th St & E Sherman Ave - #CD1501252 – Disorderly – Male urinating in flower pot. Warned.

Monday, October 17, 2011: 0048 hours

424 E Sherman Ave - #CD1501710 – Citizen Dispute – Subjects were separated when law enforcement arrived; however, one of the citizens had his bike parked near **Crickets** and someone was harassing him when he tried to retrieve it.

Monday, October 17, 2011: 0142 hours

200 Block N 2nd St - #CD1501713 – Welfare Check – Extremely intoxicated male (40's) walking down 2nd St. Subject was gone on arrival.

Monday, October 24, 2011: 0040 hours

N 4th St & E Sherman Ave - #CD1503756 – DUI – Possible DUI from Sherman. Gone on arrival.

Battery / Fights:

Saturday, October 1, 2011: 0220 hours

500 Block E Coeur d'Alene Ave - #CD1496955 – Fight – Six men in the street physically fighting and breaking items. Split up before law enforcement arrived.

Sunday, October 2, 2011: 0008 hours

401 E Sherman Ave - #CD1497241– Battery – Bartender at the **Moose** jumped by group of guys. Medical was called. The victim did not want to pursue charges. No report taken.

Sunday, October 2, 2011: 2331 hours

407 E Sherman Ave - #CD1497529 – Fight – Fight at the **Iron Horse**. Gone on arrival.

Friday, October 7, 2011: 0142 hours

N 2nd St & E Sherman Ave - #CD1498834 – Fight – Possible fight at **Splash**. Victim refused medical and did not want to pursue charges. No report taken.

Saturday, October 8, 2011: 0118 hours

N 2nd St & E Sherman Ave - #CD1499172 – Fight – Approximately four to six people fighting in front of the **Coeur d'Alene Resort**. Subjects gone on arrival.

Saturday, October 8, 2011: 1006 hours

407 E Sherman Ave - #CD1499227 – Battery – Male wants to press charges for battery that occurred the previous evening (originally did not want to press charges) and knows suspect will be at the **Iron Horse** that evening.

Sunday, October 9, 2011: 0013 hours

317 E Sherman Ave - #CD1499431 – Disturbance – Male refusing to leave the **Beacon** and possible fight brewing. Fight was verbal only and the suspect left with friends. No report taken.

Friday, October 14, 2011: 2217 hours

N 4th St & E Sherman Ave - #CD1501204 – Fight – Intoxicated male trying to fight bouncers at the **Beacon**. Subjects gone on arrival.

Sunday, October 16, 2011: 0049 hours

317 E Sherman Ave - #CD1501500 – Fight – Male starting fights with bouncers at the **Beacon** and middle of 4th Street followed by kicking things at **Java on Sherman** and acting hostile toward other people on the street before entering the **Moose Market**.

Saturday, October 23, 2011: 2316 hours

322 E Sherman Ave - #CD150327 – Threatening – Male trying to fight other people at **Splash**. Escorted out of bar, but now threatening and trying to fight other patrons. Warned.

Sunday, October 23, 2011: 0137 hours

200 E Sherman Ave - #CD1503496 – Battery – Female customer was upset and confronting and hitting an employee at the counter of the **San Francisco Sourdough**. Other activities included opening bags of chips and dumping them on the floor, hitting a manager, licking an employee's hand and entering a storage closet thinking it was the bathroom. Eventually she escaped out the back door (leaving her name information from her credit card) and entered the **Moose**.

Incidents with Arrests, Citations or Reports Taken:

Fights / Batteries / Resisting/ Disorderly

Saturday, October 1, 2011: 0117 hours

317 E Sherman Ave - #11C31034 – Battery

Officers responded to a **battery** in front of the **Beacon** involving two males who had been fighting. Upon arrival, officers contacted the victim / suspect, a 23 year old male, who was bleeding from his face. According to the victim /suspect, he had attempted to break up a fight when he was grabbed around the neck from behind, but could remember what happened after that. He declined to press charges or receive medical attention. He left but later contacted officers—upset they had not pursued the incident or contacted medical for him (not remembering he had declined these offers earlier). In the meantime, officers learned the male was actually the suspect in an assault involving the bar bouncer for which the bouncer wanted to pursue charges.

Saturday, October 1, 2011: 2115 hours

N 4th St & E Lakeside Ave - #11C31139 – Battery

Officers responded to a **battery** in front of the **Beacon** involving a bouncer who had been battered by another male (21 years) who then ran away down 4th St and punched a vehicle. When contacted, the suspect was agitated and shouting at the officers. The intoxicated, uncooperative male was taken to the ground and handcuffed. As the story goes, the male was very intoxicated when he entered the bar and was told he needed to leave. This did not sit well with the suspect who started swearing at the bar employees and attempted to punch them. The bouncers eventually pushed the suspect out the door, but when he attempted to punch the bouncers, they punched him in the face. The suspect's brothers then intervened to remove him, but a short time later the suspect returned to the bar and spit blood in the bouncers face. The male was arrested

Fights / Batteries / Resisting/ Disorderly (continued)

Saturday, October 1, 2011: 2342 hours

407 E Sherman Ave - #11C31146 – Battery

Officers responded to a **battery** in front of the **Iron Horse** involving a fight between security staff and a female (25 years). According to the female, the bouncers had been punching her brother and she had climbed on one of the bouncer's backs and hit him in the face to defend her brother. The female was very intoxicated, emotional and changed her story several times. According to the bouncers, the female was acting belligerent while in the bar and was asked to leave. She got upset and unexpectedly punched the bouncer in the face with a closed fist. The bouncer yelled at her to leave, and her brother intervened pushing the bouncer. When the bouncer then assisted the brother outside the bar, the brother became combative and the bouncer took him to the ground. This was when the sister jumped on the bouncer's back . The bouncer leaned forward and she fell off of him. She then grabbed the bouncer's leg, hugged it while lying on the ground and bit him on the ankle. Once the bouncer was able to get away from the female, she turned on her back and began to kick him on the inside of his thighs and near his groin. Officers were unable to locate the male suspect; however the female was cited for battery.

Sunday, October 2, 2011: 0030 hours

401 E Sherman Ave - #11C31330 – Battery

Officers responded to a **battery** that had occurred near the **Moose Market** involving an employee of the bar who had been jumped by 4 – 5 males while taking the garbage out to the dumpster. According to the victim, he reached up to deposit garbage in the dumpster when someone punched him in the eye causing him to fall to ground. When the victim regained consciousness, the males were kicking and punching him. The victim had money and was not robbed. It is unknown the reasons for this incident.

Friday, October 7, 2011: 2226 hours

407 E Sherman Ave - #11C31859 – Battery

Officers responded to a **battery** in the alleyway behind the **Iron Horse** involving two males. According to the victim, a 62 year old male, he was dancing with the lead singer of the band when a younger male approached, grabbed his arm giving him a 1 inch scratch on his arm. The older male wanted to press battery charges. According to the suspect, the older male was bothering the lead singer of the band, she had motioned to him for help and he approached the older male and asked him to leave her alone. The older male left, but soon returned telling the younger male, "I'm going to kick your ass!" He was told to leave again. He left, but later returned again telling the younger male the same...bouncers escorted the male from the bar. Officers then spoke with the older male who went on to tell them "the Coeur d'Alene Police Department is f—cked up and the City of Coeur d'Alene is going to hell!" When the male was contacted a few days later, officers photographed a bruise on his arm. He was still adamant on pressing charges and told officers: he is on probation for Felony DUI; he is friends with the Mayor; and he was considering calling Chief Longo regarding this incident.

Fights / Batteries / Resisting/ Disorderly (continued)

Saturday, October 8, 2011: 0121 hours

N 3rd St & E Sherman Ave - #11C31873 – Resisting

Officers responded to a **disorderly** call in the 200 block of E Sherman where two females (ages 17 & 18 years) ran away from and were chased by officers down the alley way. Officers caught the females, who were intoxicated and underage. According to the females, they had been hanging out in downtown Coeur d'Alene because two weeks prior they had figured out they could get into any Coeur d'Alene downtown bar because "they are cute." On this particular evening, they were at the **Icon**, but were confronted by an officer outside of the bar and decided to run. The girls were charged with MIP and Resisting / Obstructing a Police Officer.

Saturday, October 8, 2011: 0127 hours

200 E Sherman Ave - #11C31874 – Battery

Officers responded to a **battery** call at **Splash** involving a 24 year old male and 23 year old female. When officers arrived, they found an intoxicated and crying female sitting on the sidewalk who told them she had just been assaulted by a group of males. According to the female, she and a friend had been drinking downtown that evening but while waiting for their ride, a group of males walked by and started making fun of how she was dressed (she was wearing jeans, a baseball cap and jacket which may have made her appear to be a male.) The victim told officers, the males then jumped her, pushed her to the ground and punched her in the face. One of the suspect males was located, he was covered in blood, intoxicated and uncooperative with officers. He arrested for battery and trespassed from the bar.

Sunday, October 23, 2011: 0058 hours

107 E Coeur d'Alene Ave - #11C33462 – Resisting

Officers responded to an **unwanted person** call where an intoxicated male had tried to force his way into a residence, then passed out on the front porch. Officers had to try several times to waken the male, and when he finally woke up he jumped up and began stumbling from side to side. The officers attempted to have the male sit down so he wouldn't fall off the porch, but the male resisted and was handcuffed. When questioned by officers, the male told them he didn't know where he was; he had too much to drink that evening; he didn't know why he was trying to get into the residence and on a 1 to 10 scale of intoxication, he was a 12. The male was uncooperative with officers – refusing to tell them who he was or where he had been drinking that evening. He was arrested for **obstructing**.

DUI & Other Incidents

Sunday, October 2, 2011: 0105 hours

N 4th St & E Lakeside Ave - #11C31154 – Disorderly

Officers cited a 21 year old male for **urinating in public**. The male was very intoxicated and leaning against a tree for balance.

Friday, October 7, 2011: 0040 hours

N 7th St & E Foster Ave - #11C31764 – DUI

Officers arrested a 25 year old male for **DUI (BAC = .230)** after the male had been involved in an accident with another vehicle. The male told officers he had consumed four beers at the **Rendezvous** earlier that evening, and since he was more sober than his friend, he was driving them home. There appeared to be fresh blood in several places in the vehicle and on the suspect,

however officers were told this was from the suspect's passenger who being very intoxicated, had fallen and cut his hand prior to getting in the vehicle. The male was arrested and taken to the PSB and upon arrival the officer noticed the male had urinated on his patrol vehicle floor. When asked why he did this, the suspect smiled and said, "I told you I had to pee."

Sunday, October 9, 2011: 0044 hours

313 E Sherman Ave - #11C31969 – Theft

Officers cited a 21 year old male for **Theft** after he stole a bottle of liquor from the **Wine Cellar**. When officers arrived, the male was on the ground being detained by bar security. The male was very intoxicated and told officers he had been drinking at both **Splash** and the **Rendezvous** that evening; however he did not remember stealing the bottle (but admitted he probably did steal it because he was too drunk). He was also a little confused, thinking he had stolen the liquor at the **Icon** rather than the **Wine Cellar**. He was cited for theft.

Sunday, October 9, 2011: 2332 hours

100 Block E Borah Ave - #11C32041 – DUI

Officers arrested a 21 year old female for **DUI (BAC = .163)** after a traffic accident where she had crashed into a parked vehicle. The female admitted to officers she was driving home from the **Iron Horse**, where she had consumed two mixed drinks, when she crashed into the other vehicle. The female was cooperative with officers, and told officer she had not thought she was too intoxicated to drive.

Sunday, October 23, 2011: 0056 hours

100 Block S 5th St - #11C33461 – DUI

Officers arrested a 23 year old male for **DUI (BAC = .110)** after a routine traffic stop (driving wrong way down 4th St). The male admitted to drinking a couple of beers at the **Icon**, and told officers he was from Spokane and became confused when he turned onto 4th St.
