INTRODUCTION

This report was compiled on March 6, 2012 at the request of Captain Childers.

The types of information used to create this report include calls for service, crime reports and field interviews extracted from our Summit database.

Database records were reviewed and compiled based upon both how the record is related to a specific bar or bar activity in general in the downtown Coeur d'Alene area. The following is a table of the establishments and addresses associated with them.

Notably, it is not always possible to obtain information about where a suspect may have been drinking (e.g. too inebriated) or if a particular crime is directly related to a specific establishment. In that context, the purpose of this report is to provide a general overview of downtown activities in an effort to increase communication between bar establishments and local law enforcement with the final goal of improving public safety.

E Front Ave & S 4th St - #CD1533419 – Welfare Check – Officers responded to a call of a male passed out on the sidewalk. **No report.**

Fights / Batteries / Resisting/ Disorderly

Monday, February 13, 2012: 0030 hours

401 E Sherman Ave- #12C04135 – Battery – Officers responded to a battery call at the **Moose** involving a 39 year old male who had several lacerations inside his mouth and blood coming out of his ear and back of his head. According to the victim, he had been drinking with a friend and when his friend was getting ready to leave, the victim gave him a hug. According to the victim, several males then began making comments inferring the victim was a homosexual. These comments led to a heated conversation and the victim being knocked to the floor and kicked in the face.

Tuesday, February 28, 2012: 0150 hours

115 N 2nd St - #12C05633 – Fight – Officers responded to a battery call at the Baja Bargarita involving a 51 year old bouncer and two other males (one known male age 44 and the other suspect unknown). According to the bouncer, the two males had become angry when he had advised them it was close to closing time. Later, when walking to his truck the same two males approached him making statements about their MMA fighting experience, grabbed him from behind, threw him the ground and bounced his head off of the ice and gravel. The victim was able to get free and was struck by the suspects. The victim eventually hit the suspect across the back of the neck, ending the confrontation.

DUI & Other Incidents

Wednesday, February 1, 2012: 0104 hours

N 8th ST & E Foster Ave - #12C03055 – DUI

Officers arrested a 41 year old male for DUI (BAC = .123) after a routine traffic stop (vehicle swerving from side to side). The driver admitted to having a beer earlier in the evening at the **Iron Horse** but stated his erratic driving was due to a problem with his glasses.

Friday, February 3, 2012: 0138 hours 2700 Block N 8th St - #12C03252 - DUI

Officers arrested two brothers (21 and 28 years) for DUI (BAC = .244 & .202) after responding to their home reference a report of two males fighting in a residential driveway. Both males were extremely intoxicated and after several lies and stories admitted to **drinking downtown** that evening (various bars). Medical was called for one of the males who had a head injury. Neither male could remember how the fight started.

N 4th St & E Annie Ave - #12C03438 - DUI

Officers arrested a 41 year old female for DUI after a routine traffic stop (vehicle swerving from side to side). The driver admitted to having a several mixed drinks earlier in the evening at the **Iron Horse.** No BAC was taken (refused), but she appeared intoxicated (watery eyes, lack of balance).

Sunday, February 5, 2012: 0149 hours

N 4th St & E Coeur d'Alene Ave - #12C03438 - DUI

Officers arrested a 30 year old male for DUI after a routine traffic stop (failed to stop at stop sign). The driver admitted to having two beers at **Splash** that evening. No BAC was taken (refused), but appeared intoxicated (failed DUI test, smelled of alcohol).

Officers arrested a 32 year old male for DUI (BAC = .212) after a routine traffic stop. The driver admitted to having four beers at the **Iron Horse** that evening. The male had a prior arrest for Aggravated DUI and was arrested for Felony DUI.

Officers responded to a call at the **Pita Pit** reference a crowd of disorderly males. Apparently one of the males had walked up to a female and asked her to "take off her shirt and show her tits," to which she took offense and another male had to be held back from fighting him. One of the males, age 19, admitted to drinking an "Irish Trash Can," at the Beacon that evening (at first he was confused and kept changing his story whether he had the drink at the Beacon or Pita Pit). The male was cited for **Minor in Possession of Alcohol.**

Monday, February 12, 2012: 2310 hours

1000 Block N 7th St - #12C04228 - DUI

Officers arrested a 26 year old female for DUI (BAC = .194) after responding to a non-injury traffic accident involving her car and another vehicle. According to the female she had consumed 1.5 Moose Drool beer at the **Moose** that evening and when the traffic accident occurred she was had reached over to find her cell phone while she was driving.
