INTRODUCTION

This report was compiled on May 2, 2012 at the request of Captain Childers.

The types of information used to create this report include calls for service, crime reports and field interviews extracted from our Summit database.

Database records were reviewed and compiled based upon both how the record is related to a specific bar or bar activity in general in the downtown Coeur d'Alene area. The following is a table of the establishments and addresses associated with them.

Notably, it is not always possible to obtain information about where a suspect may have been drinking (e.g. too inebriated) or if a particular crime is directly related to a specific establishment. In that context, the **purpose of this report is to provide a general overview of downtown activities in an effort to increase communication between bar establishments and local law enforcement with the final goal of improving public safety.**

200 E Sherman Ave - #CD1552181 – Suspicious – Officers responded to a suspicious person call at **Splash** about a male who seemed paranoid around cops. The male was gone when officers arrived. **No report.**

115 S 2nd St - #CD1552519 – Poisoning – Officers responded to an unconscious male at the marina outside of the **Dock Side** who had reportedly consumed over a half a fifth of whiskey in 30 minutes. Medical was called. **No report.**

325 E Sherman Ave - #CD1553846 – Disorderly – Male jumped out into the street in front of the **Beacon**, hit the hood of a vehicle with his hands and screamed at the vehicle owner. **No report.**

320 E Sherman Ave - #CD1554481 – Disturbance – Officers responded a disturbance call involving a male on the sidewalk by the **Pita Pit** who was trying to start a fight. The male appeared to be on drugs – pacing back and forth, kicking chairs over and at one point pulled out and started playing with a knife. The victims of the incident did not want to press charge, and the male was warned. **No report.**

N 3rd St & E Sherman Ave - #CD1540672 – Fight – Officers responded to a fight call involving several subjects who had just left **Splash**. When officers arrived they found no victims with injuries, medical assistance was not required, and no one had suspect information. **No report.**

N 3rd St & E Coeur d’Alene Ave - #CD1540689 – Fight – Officers responded to a fight call across from the **Rendezvous** involving approximately 15 people and the bar staff who were trying to break it up. **No report.**

Saturday, March 17, 2012: 2130 hours

407 E Sherman Ave - #CD1542358 – Battery – Officers responded to a battery in the parking lot behind the **Iron Horse** involving an intoxicated male who had been hit by some unknown suspect. The victim did not want medical assistance or to press charges. **No report.**

Sunday, March 18, 2012: 0146 hours

216 E Coeur d’Alene Ave - #CD1542410 – Fight – Officers responded to a call about a lot of males fighting and females getting punched in front of the **Rendezvous**. **No report.**

200 E Sherman Ave - #CD1542412 – Battery – Officers responded to a call from a female at **Splash** who claimed a male at the club kept touching her breasts and the bouncers wouldn’t do anything about it. **No report.**

Tuesday, March 20, 2012: 2328 hours

N 4th St & E Sherman Ave - #CD1543134 – Fight – Officers responded to a call of eight males fighting in front of the **Moose Lounge**. The subjects were gone when officers arrived. **No report.**

Saturday, March 31, 2012: 0024 hours

N 4th St & E Lakeside Ave - #CD1546014 – Battery – Open line call to Dispatch – Males arguing and sounded like it was about to get physical then line disconnected. Warning was given to involved parties. **No report.**

Sunday, April 1, 2012: 0005 hours

216 E Sherman Ave - #CD1546304 – Fight – Officers responded to a call in front of the **Rendezvous** where someone had just punched a male in the face by a group of males, and he was bleeding from a cut above his eye area. The male’s girlfriend was crying hysterically stating the suspect males were now in the bar. Upon arrival, the victim was verbally abusive with the officers equating them to “LA cops” and saying “they didn’t give a fuck.” Officers attempted to obtain information about the suspects; however, the male victim was unable to positively identify who committed the crime and continued to be verbally abusive to officers stating he wanted to sue them and that cops don’t care about “drunk assholes” like him. **No report.**

Sunday, April 1, 2012: 1934 hours

210 E Sherman Ave - #CD1546508 – Unwanted Person – Officers responded to a call at **Tito's** reference a male who was refusing to leave. Apparently the male was very intoxicated and had walked out on his tab and when asked to leave **Tito's** the male became verbally abusive with staff and punched the chef in the face. The male was gone when officers arrived. **No report.**

Wednesday, April 4, 2012: 2311 hours

216 E Coeur d'Alene Ave - #CD1547396 – Battery – Officers responded to a call where a 21 year old male had been jumped and kidney punched at the **Rendezvous**. The victim believed he knew where the suspects lived, but did not want to press charges. The suspects were no longer on scene when officers arrived. **No report.**

Sunday, April 8, 2012: 0149 hours

N 4th St & E Sherman Ave - #CD1548197 – Fight – Officers responded to a call involving 8 to 12 males fighting in the street. The female calling in the fight disconnected after stating the fight was breaking up. **No report.**

Tuesday, April 24, 2012: 0207 hours

216 E Coeur d'Alene Ave - #CD1553190 – Battery – Officers responded to a battery call of a male who claimed bouncers kicked and punched him before kicking him out of the **Rendezvous**. The male was gone when officers arrived. **No report.**

Sunday, April 29, 2012: 0116 hours

200 E Sherman Ave - #CD1554901 – Battery – Officers responded to battery call at **Splash** involving a battery against a male that had occurred in the restroom. The victim in this event received a gash on his nose and lip and was sent to KMC for stitches. The victim did not want to press charges. **No report.**

Incidents with Arrests, Citations or Reports Taken:

Fights / Batteries / Resisting/ Disorderly

Monday, March 12, 2012: 1900 hours

407 N 2nd St - #12C06940 – Battery – Officers cited a 70 year old male for battery after an incident at the **Lakers Inn** in which the offender threw a shot of cinnamon whiskey in the face of the victim, a 53 year old female. Apparently the two had been chatting about this and that; however, the male had been continuously rude to the victim. The situation escalated when discussing whether Afghani civilians deserved being shot by US soldiers—at which point, the female stated it was the stupidest thing she had ever heard. The male, irritated by her comment, expressed his displeasure by tossing his drink in her face and then grabbing the female's drink and tossing it into her face as well. The female did not require medical attention, and the male was cited for battery.

Sunday, March 18, 2012: 0213 hours

200 Block N 2nd St - #12C07423 – Battery – Officers responded to the **Rendezvous** reference a fight call where a bouncer reported a male had hit a female, and then a fight had broken out between 4 – 5 people. The suspects had left prior to the arrival of law enforcement; however, they were later located a short distance away on 2nd Street when they ran out in front of a patrol vehicle. Three of the subjects, a female and two males, were extremely intoxicated (swaying). As the story goes, the suspect males had walked by the victim male (21 years of age) and his girlfriend, and thought the victim said something insulting to them—so they hit him several times in the head and neck. The primary offender, a 29 year old male, was arrested for battery. After he was arrested, neither the suspect nor his girlfriend (who were both intoxicated) could understand why he was being arrested, and the next day reported to the police department—so their injuries from the altercation could be photographed as well.

Sunday, March 25, 2012: 0033 hours

317 E Sherman Ave - #12C08140 – Battery – Officers responded to a battery call at the **Beacon** reference a 27 year old female who had been injured by her boyfriend's ex-girlfriend (23 year old female). According to the victim, she was in the stall in the bathroom, when the door flew open and the suspect tossed a glass at her, hitting and cutting her forehead. The suspect was later located walking down the street where she admitted to being in the bar, but denied the allegations. The suspect was cited for battery.

Wednesday, March 28, 2012: 0105 hours

407 E Sherman Ave - #12C08466 – Battery – Officers responded to a battery call at the **Iron Horse** involving two females. Notably, this is a continuation of the previous event (#12C08140) that occurred a few days prior at the **Beacon**. In this case, the previous “victim” who had a glass of beer thrown at her face, retaliated by tossing a glass of beer into the face of the “suspect.” The fight appears to be between the current and ex-girlfriend of some male. Eventually, after the case was assigned to detectives, contact made with the suspect, the victim advised she did not want to press charges, that these occurrences were all just a big misunderstanding, and the two girls had worked every out.

Sunday, April 1, 2012: 2046 hours

210 E Sherman Ave - #12C08990 – Trespassing – Officers responded to a battery call at the **Tito's** and **Splash** involving an intoxicated and violent male who had refused to pay his tab and when they asked to leave was verbally argumentative with security. Due to the male's condition, he was transported to KMC for evaluation. Once evaluation and released from KMC, he refused to leave as well, yelling profanities and becoming physical with KMC and law enforcement personnel. The 38 year old male was then restrained by officers, arrested for obstructing and “trespassed” from KMC.

Saturday, April 7, 2012: 0231 hours

216 E Coeur d'Alene Ave - #12C09563– Assault - Firearm – Officers responded to the **Rendezvous** regarding a gun that had been taken from a “crazy woman” the previous evening. According to the bouncer, he had started to follow a group of people when two males came running in his direction with a female coming up from behind with a gun in her hand. Apparently she was attempting to cock the gun but was unable to figure out how. The bouncer took the gun to keep her from hurting anyone. The gun was entered into evidence for further investigation.

DUI & Other Incidents

Wednesday, March 7, 2012: 0022 hours

401 E Sherman Ave - #12C06397 – Malicious Injury to Property – Officers responded to the **Moose Lounge** regarding property damage that had occurred during an altercation the previous evening. Initially the bar did not press charges; however, later found damage to the toilet in the men's bathroom which resulted from the altercation between two males in said room.

Saturday, March 10, 2012: 2330 hours

401 E Sherman Ave - #12C06865 – Grand Theft – Officers responded to the **Moose Lounge** regarding a theft report. The victim in the case, a 33 year old female, stated she had left her purse hanging on a hook under the bar area, forgotten about it, and the next day it was no longer there.

Sunday, March 11, 2012: 0036 hours

407 E Sherman Ave - #12C06789 – Alcohol Offense – Officers responded a disturbance at the **Iron Horse** between a bouncer and a male. Apparently the male had attempted to purchase a beer using a tribal ID card and the physical descriptions on the card did not match the male. The male was cited for Fraudulent Misrepresentation, and the ID was confiscated.

Sunday, March 11, 2012: 0113 hours

N 4th St & E Reid Ave - #12C06791 – DUI – Officers arrested a 28 year old male for DUI (BAC = .089) after a routine traffic stop (vehicle driving erratically and using wrong turn signals). The male admitted to having a few beers at the **Lakers Bar** that evening.

Thursday, March 15, 2012: 0152 hours

N Government Way & E Neider Ave - #12C07096 – DUI – Officers arrested a 20 year old male for DUI (BAC = .164) after a routine traffic stop (vehicle driving erratically and in left turn lane but turned right). The male admitted to having a few beers at downtown bars during that evening.

Friday, March 16, 2012: 2333 hours

N 9th St & E Harrison Ave - #12C07300 – DUI – Officers arrested a 27 year old male for DUI (BAC = .117) after a routine traffic stop. The male admitted to having a few beers at the **Iron Horse** that evening. The male also admitted to smoking marijuana daily and had done so on his break at work earlier that day.

Saturday, March 17, 2012: 0230 hours

N 2nd St & E Coeur d'Alene Ave - #12C07312 – Auto Burglary – Two females reported the burglary of their vehicle while parked downtown in a lot near US Bank. During the burglary, someone broke out the vehicle window and stole a purse.

Saturday, March 24, 2012: 0141 hours

N 4th St & E Montana Ave - #12C08037 – DUI – Officers arrested a 26 year old male for DUI (BAC = .141) after a routine traffic stop (vehicle driving erratically). The male admitted to having a few beers at the **Baja** that evening.

Saturday, March 24, 2012: 0257 hours

1400 Block N Norlyn Ct - #12C08045 – DUI – Officers arrested a 22 year old male for DUI (BAC = .177) after responding to a home for an “unwanted person” call. Upon arrival, officers recognized a male they had spoken to earlier in the evening who had been disorderly, intoxicated and attempting to sleep in a car in the parking lot of the **Baja**. The male was still highly intoxicated and stumbling, but apparently had driven this to location looking for his ex-wife. The male was also charged with unlawful entry (had tried to crawl through a window into the home) and battery (got into a physical confrontation with his ex-wife). He was belligerent with officers and arrested.

Saturday, March 23, 2012: 0042 hours

N 4th St & E Lakeside Ave - #12C08798 – Drugs – Officers cited a 51 year old male and 52 year old female from Spokane, WA for smoking marijuana after noticing a distinct order from a parked vehicle.

Sunday, April 1, 2012: 0041 hours

N 4th St & E Miller Ave - #12C08917 – DUI – Officers arrested a 53 year old male for DUI (BAC = .095) after a routine traffic stop (vehicle driving erratically). The male admitted to having a few whiskey drinks at the **Iron Horse** that evening.

Saturday, April 7, 2012: 0231 hours

N 5th St & E Sherman Ave - #12C09557 – DUI – Officers arrested a 22 year old female for DUI (BAC = .171) after a routine traffic stop (driving without headlights on). Her male friend told officers she had been downtown drinking that evening. During the DUI testing, the female kept repeating to officers, “fuck this, fuck this.” After officers seated her in the backseat of the patrol vehicle, the female began throwing herself against the passenger door, and at one point, she tried to kick the patrol car door. The female was restrained and taken to jail.

Sunday, April 8, 2012: 0355 hours

100 Block E Foster Ave - #12C09664 – Malicious Injury to Property – Officers responded to a call of an unwanted person in the 100 block of Foster—a residential area. The unwanted person, an intoxicated 26 year old male, was confused and looking for his vehicle. Being very intoxicated, the male thought the apartment building was a “dam” and his vehicle was parked on top of the dam. The male had been drinking at the **Beacon** all evening, and he was difficult to interview due to his level of intoxication. At some point during the incident the male had broken a door knob trying to enter the building and he was listed as the suspect in a malicious injury to property report. Officers gave him a ride home. Upon arrival, the male told officers was very impressed with how a short of time it took to get him home from Sandpoint.

Sunday, April 29, 2012: 0209 hours

N 3rd St & E Indiana Ave - #12C12091 – DUI – Officers arrested a 35 year old male for DUI (BAC = .115) after a routine traffic stop (driving wrong way down 3rd St). The male told officers he had consumed two beers at the **Rendezvous** that evening.
