INTRODUCTION

This report was compiled on May 18, 2012 at the request of Captain Childers.

The types of information used to create this report include calls for service, crime reports and field interviews extracted from our Summit database.

Database records were reviewed and compiled based upon both how the record is related to a specific bar or bar activity in general in the downtown Coeur d'Alene area. The following is a table of the establishments and addresses associated with them.

Notably, it is not always possible to obtain information about where a suspect may have been drinking (e.g. too inebriated) or if a particular crime is directly related to a specific establishment. In that context, the **purpose of this report is to provide a general overview of downtown activities in an effort to increase communication between bar establishments and local law enforcement with the final goal of improving public safety.**

Information on BAC (Blood Alcohol Content) as referenced in this report:

State of Idaho BAC DUI Laws:

- **All drivers** with a **BAC .08** or higher (**enhanced if BAC .20** or more)
- **Under 21 years of age** with a **BAC of .02** or higher
- **Commercial Drivers** with a **BAC of .04** or more

Incidents with Warnings or No Reports Taken:

Disorderly / Citizen Disputes / Alcohol / Drug Related:

Sunday, May 6, 2012: 0013 hours

216 E Coeur d'Alene Ave - #CD1557010 – Drugs – Officers responded to a call of a male getting beat up by four males near the clock tower at the **Coeur d'Alene Resort**. The victim, a 54 year old male, claimed the males had hit and kicked him because they thought he hit on a female on the Coeur d'Alene Cruise earlier. The victim did not want to press charges. **No report.**

Monday, May 14, 2012: 2121 hours

407 E Sherman Ave - #CD1560118 – DUI – Officers responded to a call from the **Iron Horse** reference a possible DUI involving a white Mustang convertible. The vehicle was later pulled over by Idaho State Police. **No report.**

Wednesday, May 16, 2012: 0148 hours

N 2nd St & E Coeur d'Alene Ave - #CD1560548 –Citizen Dispute – Officers responded to a phone call from an intoxicated male in front of the **Rendezvous**. The call was traced to the front of the bar and the dispatcher could hear a physical confrontation and someone yelling, “get in the f**ing car now.” The male caller stated the suspects were leaving and later told officer he did not know who they were but thought the incident was over a girl. **No report.**

Battery / Fights:

Saturday, May 5, 2012: 2219 hours

115 S 2nd St - #CD1556984 – Fight – Officers responded to a call reference two males who had just been kicked out of the **Rendezvous** after being caught doing cocaine in the bathroom. Officers were unable to locate the males. **No report.**

Sunday, May 13, 2012: 0208 hours

320 E Sherman Ave - #CD1559446 – Fight – Officers responded to a call reference two males fighting outside of the **Pita Pit**. The males left the area prior to the officers' arrival. **No report.**

Tuesday, May 15, 2012: 2233 hours

N 4th St & E Lakeside Ave - #CD1556023 – Domestic Dispute – Officers responded to a call reference a middle aged male and female fighting behind the **Iron Horse**. Upon arrival, officers determined the fight was not physical and the parties were not in a domestic relationship. **No report.**

Tuesday, May 15, 2012: 2301 hours

200 E Sherman Ave- #CD1560525 – Fight – Officers responded to a call reference a fight between a male and female that had started when the female had slapped the male in **Splash**. The couple then had a verbal confrontation with bouncers; however, they were not together when they walked away from the bar. **No report.**

Incidents with Arrests, Citations or Reports Taken:

Fights / Batteries / Resisting/ Disorderly:

Thursday, May 17, 2012: 0133 hours

216 E Coeur d'Alene Ave - #12C14177 – Fight – Officers responded to a battery call at the **Rendezvous** involving a group of males where some of the suspects had just driven off. Upon arrival, officers found an unconscious male (30 years of age) and his friend, a 25 year old female. Medical was called to transport the male who had apparently hit his head pretty hard against the brick wall and sidewalk. According to a bouncer at the bar, it had been chaos with a fight inside the club and while they were bringing some of the instigators outside, the fight erupted again and everyone was throwing punches and fighting. Apparently there were several groups of people involved in the altercation. Some reported the fight started with a dispute between a girlfriend bringing another male to the bar; however, once the fighting started, other began fighting with people kicking, punching and knocking each other down. The group that had left was also tracked down and had injuries as well. They told officers they had been leaving the bar, there was a fight and they had been punched as well. None of the parties wanted to press charges and without a clear suspect the case has been closed.

DUI & Other Incidents:

Thursday, May 10, 2012: 0028 hours

N 3rd St & E Coeur d'Alene Ave - #12C13235 – Grand Theft – Officers responded to a call involving an extremely intoxicated male (21 years of age) who was passed out lying in 3rd St with his head resting on the curb. The male was very unresponsive and transported to KMC for medical attention. The next day the male called in to report that someone had stolen his silver necklace and wallet some time between 2200 that evening and 0028 in the morning. The male admitted he had been drinking alcohol at the **Rendezvous** that evening. The male did not remember what happened after he had started drinking but wanted the theft on file.

Friday, May 11, 2012: 2330 hours

200 E Sherman Ave - #12C13529 – Grand Theft – Officers responded to a call involving the theft of a purse from **Splash**. The victim, a 34 year old female, told officers she had left her purse on a table with several friends; however, at some time the table was unattended, and her purse was taken.

Sunday, May 13, 2012: 0111 hours

N 2nd St & E Anton Ave - #12C13636 – DUI – Officers arrested a 50 year old male for DUI (BAC = .208) after a routine traffic stop (vehicle swerving across lanes). When asked where he was coming from, the male was too intoxicated to remember and couldn't complete his sentence. The male told officers he had consumed two or three beers that evening at the **Iron Horse**.

Monday, May 14, 2012: 2155 hours

N 5th St & E Lakeside Ave - #12C13875 – Alcohol Offense – Officers observed and cited two females (20 and 21 years of age) for liquor/ minors and open container after observing them walking down the street swaying and carrying an alcoholic beverage. The 21 year old female tried to set the drink down and admitted to leaving the **Beacon** with it. The 20 year old female told officers she had been in the **Beacon** but had not been asked for her identification. This female also told officers she had not been drinking in the bar, but had a few beers at a residence earlier in the evening. The bartender remembers the girls and had served them shots, but stated he had seen both of their identifications, and it is suspected the 20 year old may have been using a fake ID.
