## THE REFUSAL TO GRANT A PUBLIC VOTE

On May 24th, 2011 this city council approved the \$39.2 million McEuen Park Master Plan without a public vote. Since then there have been no compromises - the \$14.7 million funding has been approved for Phase I

### Phase One

- \$14.7 million without a public vote.
- Removes all of the ball fields.
- Moves the boat launch parking 5 blocks away.
- Builds a \$7 million dollar parking garage. *(Only adding a handful of additional parking spaces)*
- Built with a loan against future property tax revenues funneled into urban renewal.

The Team who designed the plan & owns the two tall condo buildings overlooking the park will receive, without a bid, a contract for \$1.9 million.
