## INTRODUCTION

This report was compiled on **August 10, 2012** at the request of Captain Childers. The types of information used to create this report include calls for service, crime reports and field interviews extracted from our Summit database.

Database records were reviewed and compiled based upon both how the record is related to a specific bar or problem activity in general in the downtown Coeur d'Alene area.

In that context, the purpose of this report is to provide a general overview of downtown activities in an effort to increase communication between bar establishments and local law enforcement with the final goal of improving public safety.

# Incidents with Arrests, Citations or Reports Taken:

## Fights / Batteries / Resisting/ Disorderly:

#### Sunday, July 1, 2012: 0122 hours

**200 Block E Lakeside Ave - #12C19693 – Resisting –** Officers were hailed by a male waving his arms and claiming he was being chased. The 24 year old male was very intoxicated, and when officers attempted to find out what had happened, the male would only yell at them that they "weren't doing anything." The male was very angry, swinging his arms at the officers while he yelled at them. Another male and a female approached the officers and told them that the angry male had been in the **Rendezvous** earlier causing problems – bumping into another guy that was part of a bachelor party and starting a fight. Once the group started fighting, bouncers broke it up and kicked everyone out. The bachelor party group then started chasing the male down the street. While the officers were getting to the facts of what had happened, a group of males from the bachelor party arrived and both the group and the male began yelling threats and obscenities at each other. None of the males would listen to officers and a large group was forming. Back up police officers were called in. One of the bachelor party males was pepper sprayed and arrested. The male who started the ruckus turned and ran from officers and had to be chased down by a

bike patrol officer. This male, when handcuffed and deposited in the Patrol vehicle began to bang his head, cutting his forehead and having to have a protective helmet fitting to his head. He was taken to the hospital to be checked out prior to his trip to jail. The two major offenders in the altercation were arrested and charged with obstructing and disturbing the peace. The male who started the conflict was also charged with probation violations after his probation officer was contacted (misdemeanor probation for DUI).

### Wednesday, July 4, 2012: 2223 hours

N 6<sup>th</sup> St & Lakeside Ave - #12C20260 – Battery – Officers responded to a fight call where one male was chasing another male down the street trying to strike him. According to one of the males, he and his family were walking down the street after the fireworks when a male jumped out and grabbed his wife's butt. The male then pushed the suspect who being intoxicated stumbled into the Post Office parking lot. At this point, the suspect's family started yelling at the victim's husband telling him they were going to call the police. The victim's husband told them to do that while he called into the police himself. Seeing the male call the police, the suspect then ran off on foot but his family remained continuing the verbal altercation with the victim's family. The suspect, a 16 year old make was later located and admitted to grabbing the woman's butt as a dare. He was charged with battery.

#### Wednesday, July 4, 2012: 2232 hours

**300 E Front Ave - #12C20265 – Fight** – While monitoring the crowd leaving the 4<sup>th</sup> of July fireworks, officers observed two intoxicated males: one of the males (22 years) was very intoxicated, staggering while the other male (15 years and also intoxicated) was helping him walk. When approached, the younger male had a hard time communicating – slurring his words and could not spell his own name, and when he opened his backpack it contained illegal fireworks and an unopened can of beer. Initially he denied the backpack belonged to him, but eventually admitted to owning it. The older male (22 years) was extremely intoxicated, belligerent and created a huge disturbance (throwing his arms up in the air, flipping off the officer and taking a fighting stance while yelling and challenging the officer to a fight). This male's tirade began to incite some yelling from the huge crowd surrounding them. When officers began to handcuff the older male, he began to struggle, and it took several officers to gain control and take him to the ground. The younger male was charged with Minor in Possession of Alcohol and Tobacco eventually released to his parents. The older male was arrested and charged with Fighting in Public, Intoxicated Person in Roadway, Distributing Tobacco to a Minor and Littering.

#### Thursday, July 5, 2012: 0222 hours

**Northwest Blvd & W Garden Ave - #12C20325 – Domestic Battery –** Officers arrested an 18 year old female for Domestic Battery after a dispute between her boyfriend (bisexual) and her boyfriend's boyfriend (homosexual). The battery incident occurred after the fireworks display in the **Spokesman Review** parking lot. Apparently the three were discussing sexual preferences, and the female, who was intoxicated, was not happy about the situation – slapping her boyfriend's face (victim stated it was like a "bitch slap"). When officers arrived, everyone was in tears and once it was determined the male and female were in a domestic relationship, she was arrested for domestic battery. Her boyfriend was later charged with Malicious Injury to Property after it was discovered he had stolen a "handicap" sign from the parking lot area (sign was found in his car).

#### Friday, July 6, 2012: 0125 hours

**407 E Sherman Ave - #12C20464 – Battery –** Officers contacted a 23 year old male reference his 20 year old girlfriend hitting him several times. As the story goes, the male knew the girlfriend had ordered a fake identification off the Internet, so when he got off work he headed downtown to find her. He did find her, intoxicated and hanging all over another guy in the **Iron Horse** back parking lot. When he asked her what she was doing, she laughed and told him she was now with this other guy, and they were no longer together. This was news to the male. When the female attempted to leave with the other male (who was also intoxicated), he attempted to stop them from getting into a vehicle. At this point, his "girlfriend" kicked him in the balls and punched him in the face and neck area six to eight times. He then attempted to hug her to get her to stop, but when this did not work, he left the area and later called the police to report the battery stating "she should not treat him this way." A few days later the male told officers he no longer wanted to press charges, and the case was dropped.

#### Sunday, July 8, 2012: 1731 hours

**415 W Mullan Rd - #12C20822 – Battery –** Officers responded to the **City Beach** where a 15 year old girl was beaten up by a 17 year old girl. The two girls knew each other, but the victim did not know why the other girl disliked her. The suspect arrived with several other girls who challenged the victim to a fight, began hitting her, pulling her hair, and slamming her head into a cement wall. The victim was taken to the hospital for treatment and an investigation in ongoing into the matter.
