NARRATIVE:

I was dispatched to the report of a automotive burglary where the reporting party had the suspect detained near the intersection of N 10th St and E Harrison Ave. Officer Wilhelm and I arrived on scene simultaneously. I observed three individuals in the above mentioned location. One male was wearing only shorts, (Shane Allen Miars) another male was standing near the curb (Shane Earl Miars) and the third was sitting on the curb (). Both Shane Miars went to speak with Officer Wilhelm.

I read his Miranda Warning from my Miranda Warning card. said he understood his rights and was willing to speak with me about what happened. He said he was hanging out with a friend near Lakes Middle School. He then was walking to his brother's house on N 10th Pl. He described his friend's house as being near Coeur D' Alene Ave and N 16th St, which is not near Lakes Middle School. He said the two males that Officer Wilhelm was speaking with began chasing him. They caught him at our present location and then law enforcement showed up.

denied ever trying to open any car doors. He also allowed me to search his backpack and coat. Inside his coat I found nothing to suggest he had any property other than his own. He had the normal hygiene products that one would expect a person to possess.

I spoke with Officer Wilhelm about what the reporting parties told him. He

told me they did not wish to press any charges. He also was informed that entry was never gained into their vehicle, because it was locked. When he looked for evidence, there was none due to both door handles being handled by the reporting parties after allegedly did. It was unclear if the remained at the vehicle door for an extended period of time or tried to open it in passing.

Officer Rios also drove through the neighborhoods looking for any additional signs of auto burglary. He observed vehicles with frost on them that did not appear to have been touched. With no evidence of any burglaries and a victim who did not want to press charges, I released on scene.

On 03/11/13 I was dispatched as a secondary Officer to a call of a possible 'interrupted' Burglary in progress. The call details indicated the reporting party had chased and detained the male suspect.

I arrived on scene and spoke with a male, verbally identified as Shane Miars. Shane told me the following: He had chased a male from his residence to our current location (just south of 12th and Harrison Ave.). The male, later identified as had 'tried to get into his vehicle.' Shane and his son, also Shane, chased the male, tackled him and detained him until LE arrived.

I spoke briefly with Shane (jr.), he told me he had tackled and 'worked over' after he noticed him by one of the family vehicles outside the residence.

Shane Sr. stated he did not wish to pursue charges because of the injuries 'they' had inflicted on He stated there had been clear fingerprints on the vehicle due to the frost/ice on the car. The prints were no longer visible due to Shane using the door handles.

The information attained from the two males was passed along to primary Officer Pleger.

NARRATIVE:

On 3/13/2013 at 0708 hours, I contacted Shane Earl Miars by phone. He told me the following: His son, Shane Allen Miars, woke up to the sound of a cough outside his window. He then looked outside to see someone trying to open his father's car door. He went downstairs and woke up Shane Earl. Shane Earl then went outside to check for the male, but could not find him. He told Shane Allen

that he was seeing things. Shane Earl then checked his vehicle's door handles and observed fresh hand prints in the frost. He and Shane Allen got into his vehicle and began looking for the male. They drove through the neighborhood and located the same male. Shane Earl confronted the male asking him why he was trying to get into his cars. then "bolted." They grabbed , but he still tried to get away. Shane Allen grabbed onto and their momentum took them to the ground. Shane Earl told that they were going to wait here and get this thing hashed out. was pleading with Shane Earl not to call the police. Then law enforcement arrived on scene.
