Saturday/Sunday Swing & Night Shifts:

Officers responded to 55 calls for service on swing and night shifts yesterday, including 8 citizen assists, 5 medical assists, 5 suspicious incidents and 2 welfare checks, as well as:

Friday/Saturday Swing & Night Shifts:

Officers, dispatchers and volunteers stayed extremely busy on swing shift and night shift with storm-related calls. Night shift officers were called in early for coverage and several volunteers came in to help with traffic hazard calls. Some calls caused by the storm include:
