

Post Falls Police Activity Report – 1.23.15

Day Shift:

15PF01500-Suspicious-E 13th AVE-RP reported observing two males standing in the neighbor's yard/car port. Officers responded and located two males in the alleyway behind a residence on E 13th Ave. The story officers were given by both males was they were out looking for their pit-bull puppy, which had been let out this morning to go potty and it walked off. No pup was seen in the area at the time of the contact.

15PF01502-Theft-E 13th AVE-RP reported she believed gas had been siphoned out of her vehicle, which was parked in the driveway of the residence. RP felt gas had been siphoned due to tracks in the snow leading up to her vehicle and away from it. Officers and the victim did determine gas was not siphoned from the vehicle and no crime had been discovered at the time of the contact. It is believed that the two males from 15PF01500 are involved due to the prints in the snow matching the shoes they were wearing at the time of the contact.

15PF01526-Burglary residence-E 16th-RP/Victim reports she and a second victim suspect two males broke into their residence and stole items to include a game console, Halo charges, locked safe with vital paperwork inside, CD's and such. RP said she left for dinner and the house was locked and gate closed. When she returned she observed the carport gate was left open and the deadbolt on the house door was locked. The RP said when she left; the house was locked, excluding the deadbolt. That is when the victims discovered items stolen from the residence.

Graveyard Shift:

An Officer contacted the driver of a vehicle that was in a suspicious area. It was determined the driver was operating a motor vehicle while under the influence of alcohol though she claimed not to have been drinking. The driver was arrested for DUI and Open Container. deposited the check and withdrew the \$350 (spending some of it) they were notified that the check was a fake. Report taken

15PF01475- Drugs/Juvenile problem Juvenile female was contacted by the principal and appeared to be under the influence of a drug. Officers responded and talked to the juvenile and her mother about her drug use. She admitted to using methamphetamine on the previous evening/morning, but was not an addict. Juvenile was released to the mother and a report was taken.
