

Here are some highlights from Swing & Graveyard Shift (Feb. 4, 2015):

Fight - Officers responded to for a report of a physical fight in progress between brothers. Upon officers arrival parties were separated and one party had already left the scene. Officers were advised it was a verbal altercation only

Reckless Driving - 3500 Blk E 2nd Ave Officers were dispatched to a report of a reckless driver. The driver and vehicle were eventually located at Wendy's. The RP advised the driver struck a curb and a trash can while driving away from the RP's residence in a reckless manner. The driver admitted to striking the trash can with his vehicle and damage was discovered to the passenger side mirror. The driver was cited and released for Reckless Driving.

Property Damage/Non-Injury Collision, Seltice Way and Chase Rd

Two vehicle collision occurred when the driver of unit 1 failed to notice unit 2 was making a left hand turn in front of unit 1. Unit 1 rear ended unit 2. The driver of unit 1 was cited for following too closely.

Attempted Burglary -Cold report of an attempted burglary where the RP found pry marks on the door of his shop. Entry was not made and nothing was stolen. The RP did not wish to pursue any charges so an informational report was taken.

DUI/Racing, Seltice Way and Silkwood Dr - Sgt. James observed two vehicles leaving the Falls Club and observed them swerving, speeding, driving recklessly, and racing side by side while travelling W/B on Seltice Way. A traffic stop was attempted on both vehicles simultaneously however only one vehicle stopped. The driver was ordered to stay there while additional units responded. Sgt. James continued on trying to catch the lead vehicle which did not stop upon his initial attempt. The vehicle was caught and stopped at Seltice Way and Silkwood; the female driver was observed to be under the influence and subsequently was arrested and transported to PSB where she provided breath sample and was booked for DUI.

Part two.....The driver of the 1st vehicle, which stopped initially then fled after Sgt. James left to catch the other vehicle, was identified and contacted by phone. The driver admitted he had been driving the vehicle but denied racing and denied operating while under the influence. The driver was requested to respond to the PD for a citation for Racing on a Public Roadway and he advised he would be right down. Surprisingly, the driver failed to show and failed to answer additional phone calls. Charges are being requested for Racing and Obstructing - Report taken.

Drugs - Cecil Rd and Lapis Ave Officer Harrison observed a suspicious vehicle and initiated a traffic stop after observing the vehicle crossed the center line. The odor of marijuana was detected and a vehicle search resulted in finding marijuana and paraphernalia. The driver was cited and released for possession of marijuana and possession of paraphernalia.

Domestic Dispute – Female was battered by her ex-husband who pushed and punched her in the chest. The male was gone prior to officer arrival. The male destroyed the female's cell phone after she advised she was calling police. Officers checked the area for the male but were unable to locate – report was taken.
