<u>Post Falls Police Department activities report – Feb 1-2:</u>

Day Shift:

Domestic Dispute-Male vs female. Husband broke down garage door. Female and children were locked in the basement. Possibly drug use involved. A report was taken.

Theft-Items stolen from construction site. A report was taken.

Crash-Minivan vs small pickup-no injuries.

Suicide Threat-Male got out of hospital 3 days ago, had a knife and wanted to end it all. Male was cooperative and requested help.

Theft- Caller stated that someone stole a muzzle loader from him. Unknown time frame, unknown serial number.

Crash- 3 car crash unknown injuries. After investigating it turned out to be a DUI crash. An arrest was made.

Officers responded to many other miscellaneous calls for service. There were no major incidents on this shift.

Graveyard Shift:

15PF02093 - W Seltice Way - Owners responded to their store after an alarm and found glass doors had been smashed out and some goods had been stolen. Officers arrived and cleared the business. Video was reviewed and found to have good images of the suspect. Report taken.

Officers attended to medical assists, phone contacts, traffic offenses, ect... Nothing further to mention.

Swing Shift:

Swing shift officers responded to 23 calls for service including 8 medical assists, 2 welfare checks, 1 noise complaint and 1 lock out. It was a fairly quiet shift.

Day Shift (Sunday):

15PF02058: Found Property

Reporting party found a cell phone in Falls Park and brought it to the Police Department. The owner was unable to be located and the phone was placed in evidence.

15PF02064: Welfare Check

Officers and medical responded to S Harbor Park Ct for a welfare check. The reporting party advised she was on the phone with her 90 year old mother and stated she had fallen and hit her

head. The reporting party said she was not able to get her mom back on the phone and was concerned something happened to her. Officers arrived at the residence to find it completely locked up and unable to get the female to answer the door. Officer Morris located the female and crawled through the dog door and was able to make contact with her laying on the dining room floor and unable to move without assistance. She was checked out by medical staff and the daughter (in Florida) was advised of the situation.

Graveyard Shift (Sunday):

There were a few calls for service but nothing noteworthy other than...

15PF02048-Found Child, Super 1

A man on a bicycle found a 6 year old boy walking south on Idaho Street and brought him to Super 1 to meet an officer. It was found that the boy was staying with friends and became homesick so he started walking towards mom's house without waking anyone. Officers were unable to contact the mom, but dispatch located his grandmother's info and she took the boy for the night. Grandma was able to contact the family who had been watching him and let them know he was with her and ok.

Swing Shift (Sunday):

15PF02023- Possible theft/scam involving craigslist. RP stated that a friend of theirs traded cell phones with a person they meet on Craigslist, well it ended up the phone that the friend got was disabled by the carrier and unusable. They have not been able to get in contact with that person and wanted a report filed.

15PF02024- Warrant arrest at N Lincoln St. Officers were returning a dog that was found wondering to this address and found that the male that lived there had a warrant for his arrest. When officers arrived they contacted the dog owner and took him into custody on traffic related warrants without incident.

15PF02030- Possession of stolen property/Possession of drug and paraphernalia. RP called stating a vehicle had been broken down in the parking lot of their business and had been there all day, the RP suspected the parties were on drugs. When officers arrived a male and female were contacted. During the investigation it was found that the male had tin foil in his pocket that was used to smoke prescription drugs. Also found in the vehicle was a debit card and it was found that card was stolen out of Spokane, in which the was seen leaving in a gray van, similarly the vehicle we located broke down at this location . After the investigation both the male and female were taken into custody for the possession of the stolen credit and possession of paraphernalia.

15PF02041-DUI started at I90 at MP3. Vehicle was swerving and cut off one vehicle before a stop was attempted. When the emergency lights were activated the driver did not yield and exit at Spokane street, coming to a stop at 4th and Spokane. Speeds never went over 50 mph on the freeway. The driver failed sobriety tests and was taken into custody. At the jail the offender blew .13/.12. Incidentally the offender has not had a valid license since 2008.
