



Coeur d'Alene Police – Crime Analysis

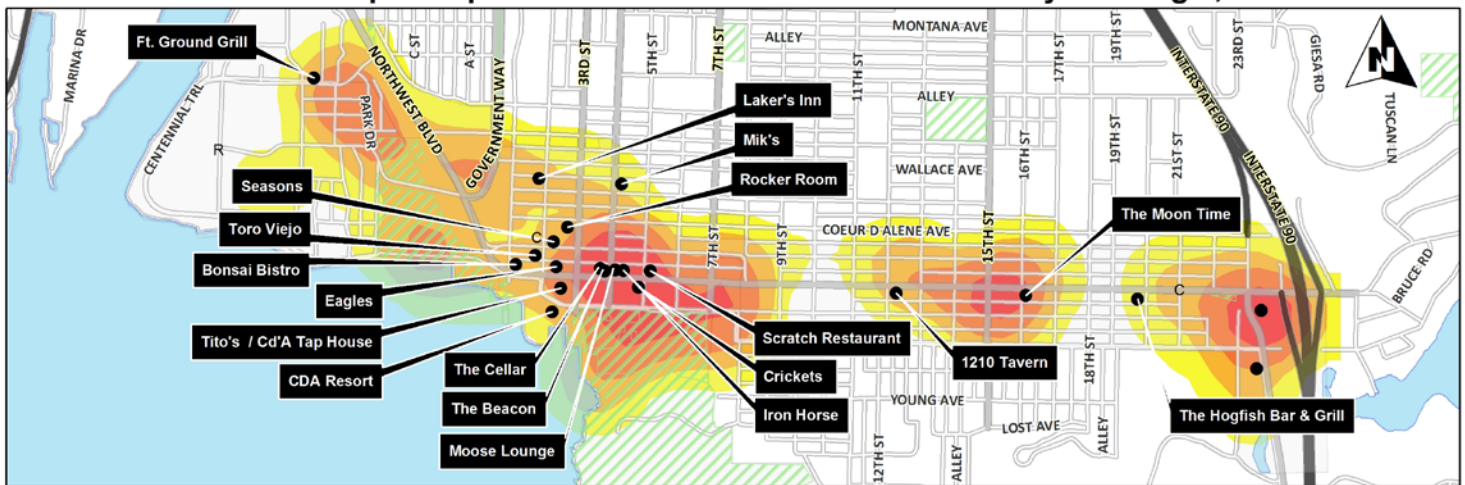
Downtown Activity / Crime Report: July 29 – Aug 4, 2015

The types of information used to create this report include calls for service, crime reports and field interviews. **These records were reviewed and compiled based upon both how the record is related to a specific bar or problem activity in the downtown Coeur d'Alene area.** Notably, it is not always possible to obtain information about where a suspect may have been drinking (e.g. too inebriated) or if a particular crime is directly related to a specific establishment. In fact, the below **“hot spot” maps reflect ALL calls or crimes reports** – not just those directly related to downtown bars. In that context, **the purpose of this report is to provide a general overview of downtown activities in an effort to increase communication between bar establishments, businesses, residents and local law enforcement with the goal of improving public safety.**

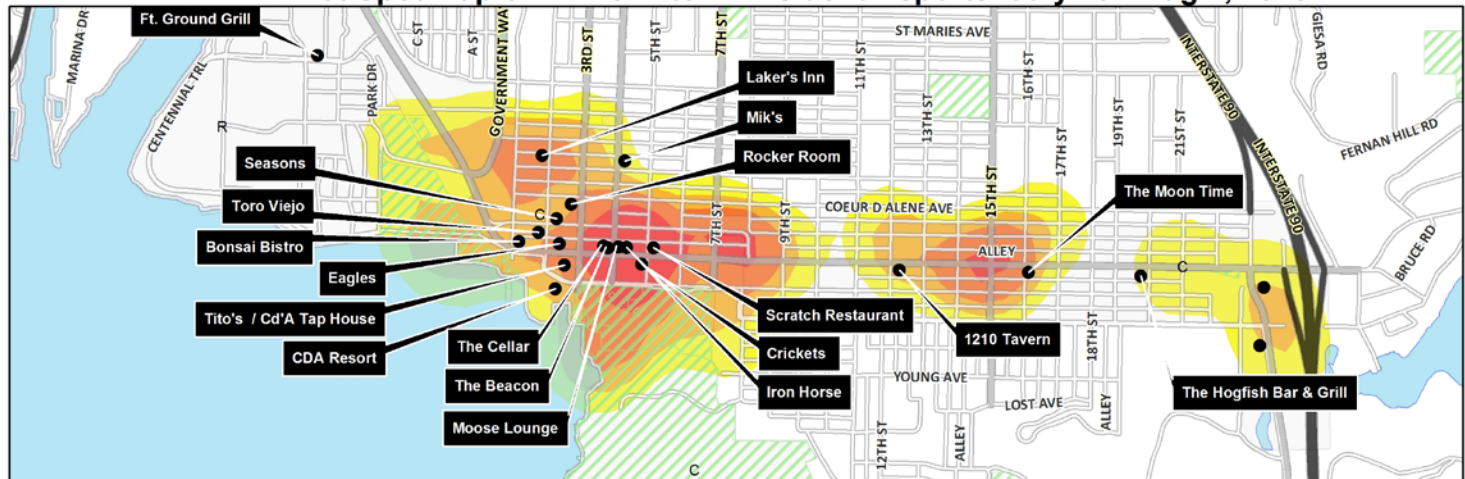
Information on BAC (Blood Alcohol Content) as referenced in this report:

State of Idaho BAC DUI Laws: All drivers with a BAC .08 or higher (enhanced if BAC .20 or more) or Under 21 years of age with a BAC of .02 or higher or Commercial Drivers with a BAC of .04 or more.

Wednesday, July 29, 2015 -- 07:22:28 hours -- N 15TH ST & E SHERMAN AVE -- FALSE REPORT -- EXXON FOOD MART -- Officers responded to a Robbery call at the Food Mart and ended up citing a 33 year old Las Vegas woman for False 9-1-1 Report. After officers responded to the call and realized no robbery was taking place, a woman walked over to them from the direction of Fresh Start and asked if they were the "real police," stating gang members were using "K27" as part of their gang symbol and hanging out at the CDAPD Station 2. She admitted to the False 9-1-1 call, but then appeared to be unstable -- going off on a tangent about not feeling safe with "fake officers" running around, etc. The same woman was arrested later that day at Independence PT on Drug Possession and Trespassing charges. #15C24208
