Domestic Battery husband & wife – hit her in the face and attempted to strangle her. He was arrested Previous battery report in July; 3. Domestic Battery boyfriend & girlfriend – Attempted Strangulation. <u>Arson</u>: Cold report from previous incident / Arson investigation ongoing. <u>Robbery</u>: Possibly drug related (see description next page).

<u>Auto Burglaries</u>: 1. Tubbs Hill parking lot. Over \$2,000 in jewelry, sports equipment and makeup stolen. 2. Woofer stolen from vehicle parked at residence in 5500 block of Parkwood Circle. 3. Gas stolen from vehicle parked at residence in 3200 block of N 4th St. <u>Residential Burglary</u>: 1. Unoccupied house broken into in 900 block N Hedberg Dr 2. Vacant house broken into in 2000 block of N 12th St. and transient male arrested 3. \$2,000 golf clubs stolen from garage in 2000 block W Daly Dr – occurred late at night when victims were home. 4. Satellite radio & electronics stolen from garage in 2500 block W Canyon Dr – also at night when victims were home.

<u>Thefts</u>: Various circumstances such as family stealing cash from family, karate student stealing from a locker room bag, workers helping an elderly move taking her belongings, a purse stolen in a thrift store, wallet left in gas station rest room, a stolen tablet from NIC Skills Lab that was later recovered by SRO (suspect charged) and the theft of an alcohol monitoring bracelet (probationer did not return).




