Two of the juveniles have been identified and SROs will be contacting them. 2. Two burglaries reported in the 1900 block of N. 7<sup>th</sup> Street. Detectives are working a possible lead.

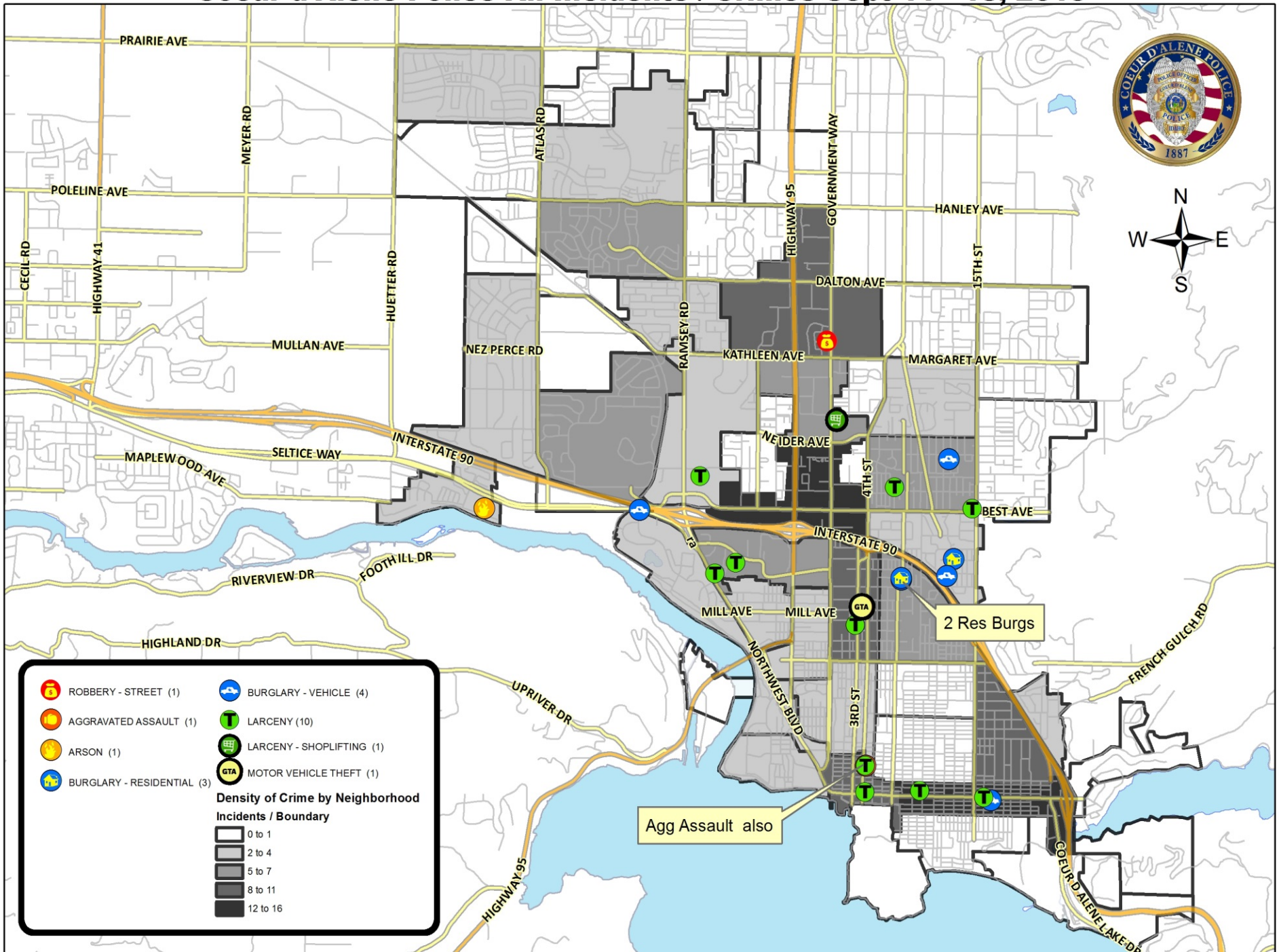

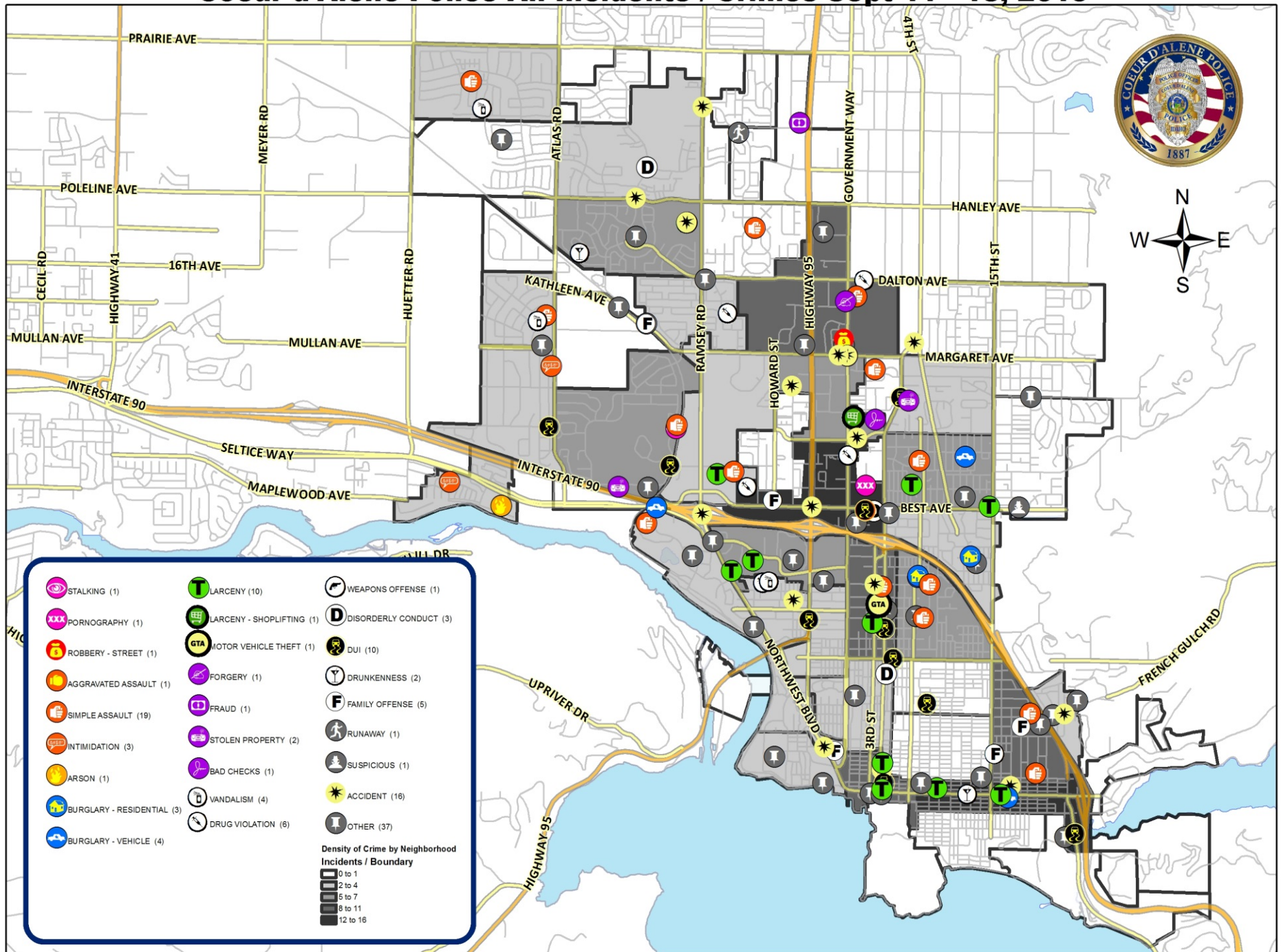

Notably, Kiarrah had changed her appearance and now has pinkish red hair and may be hanging out with a 29 year old transient male.

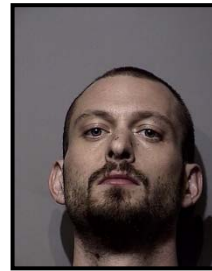
Law enforcement and her family are concerned for her welfare because of the length of time she has been away from home and her hazardous behavior.

Kiarrah is 5' 4", 115 pounds, with blue eyes and with blonde or recently dyed pinkish red hair. She was last seen wearing blue jeans and carrying an orange shoulder bag with a peace symbol on it. Kiarrah is believed to be in the Coeur d'Alene area.

LE has returned to the area in an effort to remove the transients and their camps/tents that they have set up. Thursday morning six transients were contacted and removed from the area.



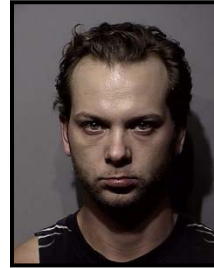
