**Residential Burglary (1):** 6600 block of N. Talon Lane – Attempted entry to residence.

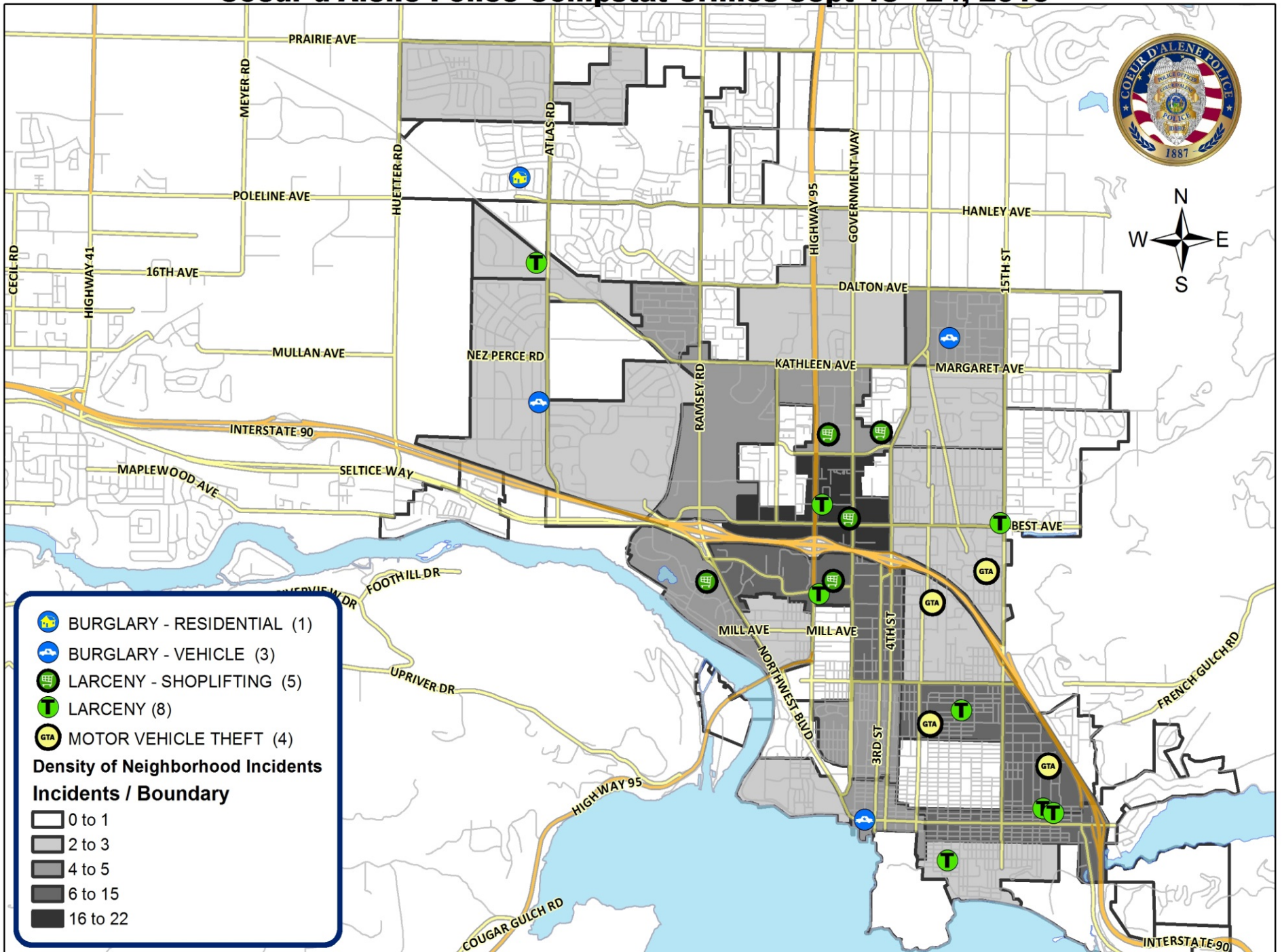

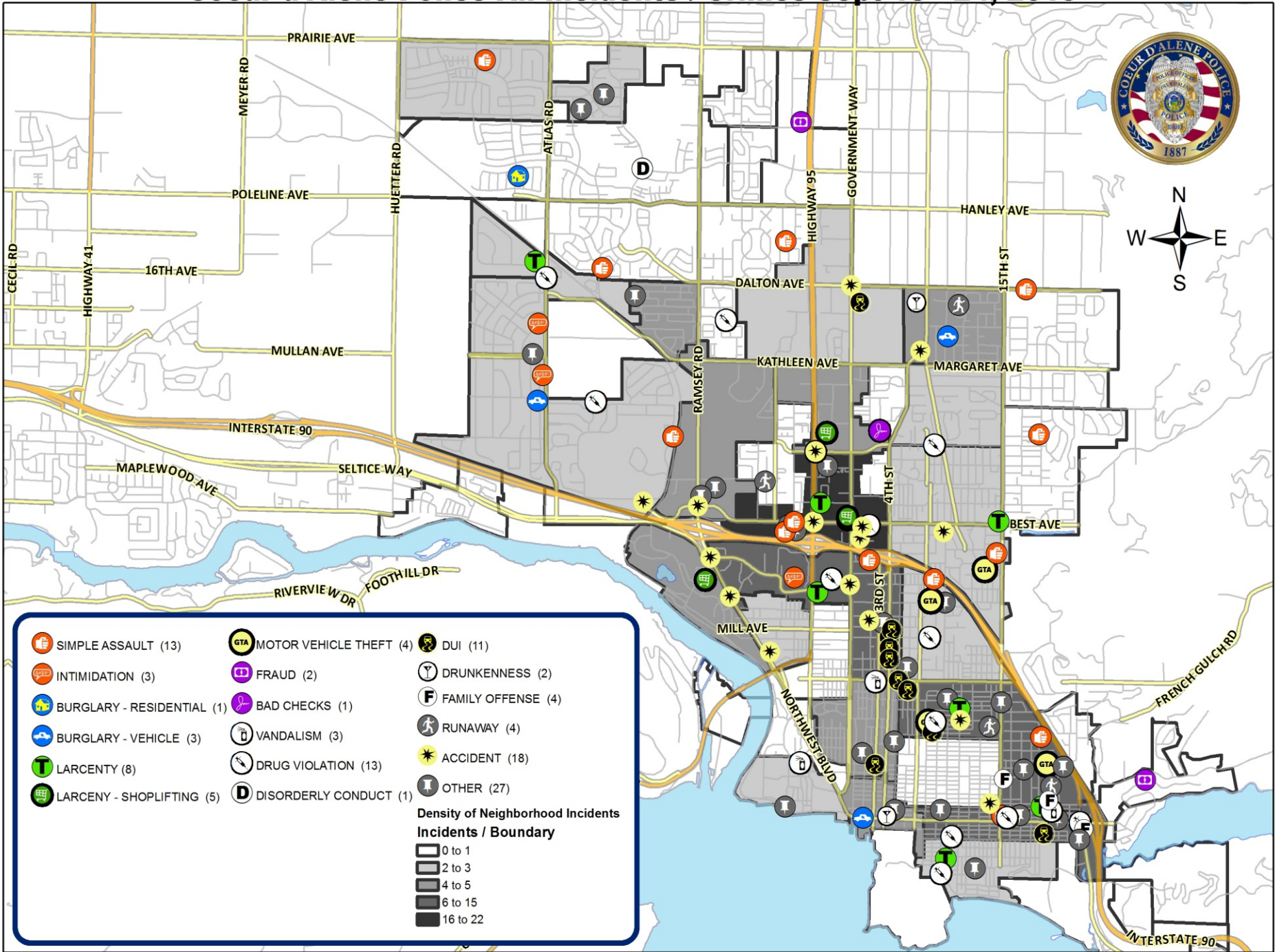

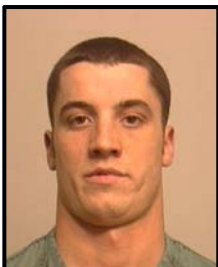
