Last night I reviewed 7 day pre-primary campaign finance reports for Bryan Zollinger, Randy Neal and Chick Heileson and noted that again it appears that Mr. Beck may be attempting to maneuver around campaign finance by funneling funds through companies he claims he doesn't own, a claim which conflicts with research done by "Eye on Boise" reporter Betsy Russell below.
