City Begins Chip Sealing on Monday

The City of Post Falls Street Division will begin chip sealing City streets on Monday, July 25. The chip sealing is expected to be completed on Thursday, July 28, weather permitting. The chip seal project will cover 7 miles of residential and commercial streets. Visit the City's website at www.postfallsidaho.org to view the Chip Seal Project map.

Drivers may experience periodic lane closures and should expect minimum delays. Garbage pickup in these areas will not be affected. Residents should place their garbage toters at curbside as usual.

The City asks that residents remove all vehicles from streets. Violators will be towed. No parking on the streets beginning July 25th and from 6 am to 6 pm for two weeks after chip seal is placed. The sweepers will be operating to sweep up loose rock chips. Do not run sprinklers in the street the day before, the day of chip sealing, and 24 hours after; streets must be dry. Drive slowly the first two days and refrain from making sharp turns. Traffic will be allowed on streets during the application of the chip seal with short-term delays and temporary lane closures. To avoid rock chips, the speed limits may be reduced within the work zones until the newly-sealed streets are swept clean of the chips. Please avoid the

construction area and find alternate routes when possible. Avoid walking on the chip seal material, or remove shoes if you do. It will not come out of carpets.

Chip Seal is a polymer oil seal with a rock-chip wear surface that seals asphalt. We will begin chip seal placement on Monday, July 25, 2016, and end on Thursday, July 28, 2016, weather permitting. Time of completion: approximately four days. Chip Seal Project: 7.00 miles of chip seal on both residential and commercial streets:

Monday, July 25, 2016, weather permitting:

- Public Works Way
- Seltice Way from Chase Road to Spokane Street
- Spokane Street from Seltice Way to Poleline Avenue Tuesday, July 26, 2016, weather permitting:
 - Seltice Way from Bay Street to Greensferry Road
 - Seltice Way from Greensferry Road to Exit 7, ITD/41

Wednesday, July 27, 2016, weather permitting:

- Handy Street from 3rd Avenue to Plaza Drive
- Greensferry Road from 3rd Avenue to Ponderosa Boulevard
- Ponderosa Boulevard from Greensferry Road to Ross Point Road
- Spencer Street from Ponderosa Boulevard to 2nd Avenue

Thursday, July 28, 2016, weather permitting:

- Dart Street from Laurel Street to 2nd Avenue
- Linden Street from Dart Street to 1st Avenue
- Laurel Street from Mountain View Drive to 1st Avenue
- Ist Avenue from Spencer Street to Ross Point Road
- Pinewood Drive from Ponderosa Boulevard to 1st Avenue
- Maplewood Avenue from 1st Avenue to Ross Point Road
- Ridgewood Drive from 1st Avenue to Ponderosa Boulevard

Please remove all vehicles from streets. Violators will be towed. Please keep water off of the streets—there must be NO water on the streets. No Parking on the streets until the loose chips are swept. Please drive slowly to avoid damaging your newly-sealed roads. There will be periodic lane closures. Expect minimal delays.
