6 kind or nature establishing the heirship of either Jonathan Clark or Scott Miller as  
7 requested by Ms. St. Louis.

8 Whereas Ms. St. Louis has also stated that the documentation she requested  
9 was to be “at a minimum . . . a certified birth certificate,” I have accordingly met  
10 said request. To my knowledge, no documentation of any kind or nature has been  
11 submitted by the prospective heirs Jonathan Clark or Scott Miller regarding their  
12 heirship.


14 While I was told by my parents that I was adopted, obviously I don’t recall
