On 01/20/09 I spoke with Jeanine Brown concerning the theft of her wallet.

Jeanine told me she was in Goodwill on 12/30/08 at approximately 1645 hours. She was carrying her small, slim wallet underneath her arm as is her practice. Someone bumped into her, a female, and Jeanine excused herself and thought nothing more about it. Within a few minutes she noted her wallet was missing. She and a friend looked everywhere for the wallet but were unable to locate it. Jeanine did not report the theft because she had no suspect information and didn't think the police could help her. When she went to notify her bank to cancel her debit card Jeanine was informed that the card had already been used. Jeanine stated the card was used at a Wells Fargo ATM on Ironwood Drive in the amount of \$260.00. It was used again at an ATM in Rathdrum ID for \$100. Then a false deposit of \$500 was made in Rathdrum by use of an empty envelope at the ATM. Jeanine provided a transaction history from Wells Fargo showing the unauthorized activity. Jeanine was shown a surveillance picture by her bank but did not recognize the person in the picture. She said the picture was so bad she couldn't tell whether the suspect was male or female. She was unsure if further surveillance was available.

NARRATIVE:

On 01/20/09 I spoke with Thomas Coit concerning the theft of his vehicle.

Thomas told me he parked his truck in the parking lot of Sunset Park, 13th and Best Avenue, with a For-Sale sign in the window. He last saw the vehicle at 0930 hours on 01/16/09. The vehicle was locked and the keys were in Thomas's possession. When he returned to check on the vehicle at 1030 hours today he discovered it missing.

Thomas could provide no suspect information. He does not owe money on the vehicle and is the sole owner of the vehicle. The vehicle is uninsured. No one else has keys to the vehicle.

Thomas came to the PD and signed a vehicle theft report. I faxed a copy of the report to Dispatch to be entered into NCIC. The original vehicle theft report is attached to this report.
